FUFA Big League Clubs

RE: FCC VERDICTS ON USE OF INELIGIBLE PLAYERS.

The FCC held a meeting on Monday April 7, 2014 at FUFA House and found out that FBL Clubs have been fielding players with cautions and send offs in league matches. The FCC has invoked the following provisions of the rules to pronounce the following verdicts.

FUFA Competitions Rules;

Par 8 states;

A player who earns three (3) bookings (cautions) in a league competition shall automatically become an ineligible player for the next physically played match.

Par 10 states;

A player who is sent-off the field of play (Send-off) by accumulating two (2) bookings (cautions) during the same league competition match or directly sent off the field of play during a league competition match shall automatically become an ineligible player for the next two (2) physically played matches

AND

Art 19 par 9 states,

A Club that fields an ineligible player in a FUFA Competition Match shall lose the match by forfeiture to the opposing team.
