Representation to International Competitions

In relation to sporting integrity of the competition "taking other consideration of the relevant FUFA/CAF and CECAFA regulations constant f", the FCC wish to extract the following provisions of FUFA Competitions Rules in relation to representation in international club competitions

Article **16** Representation in International Club Competitions

1) For Club Licensing and/or disciplinary reasons, FUFA reserves the final authority to determine the club to represent Uganda in all International club competitions without compromising sporting integrity.

3)The final table standing of the FSL shall provide the priority order of eligibility to represent Uganda in the CAF Club Champions League and CECAFA Club Championship.

4)The final positions of the Uganda Cup Competitions shall provide the priority order of eligibility to represent Uganda in the CAF Confederation Cup.

5)Where a club wins both the Uganda Cup and tops the FSL Table, FUFA shall only nominate such club to represent Uganda in CAF Club Champions League.
