**RE: DISTRICT FOOTBALL ASSOCIATIONS ELECTORAL PROCESS AND TIMELINES**

In accordance with Art 10 par 1 of the FUFA Electoral Code, the FUFA Electoral Committee (FUFA EC) hereby issues a schedule of electoral events for the upcoming elections for the District Football Associations in accordance with the electoral guidelines.

**1. FUFA Electoral guiding documents**

The FUFA Statutes, FUFA Electoral Code and FUFA Electoral Guidelines shall govern the electoral process of all District Football Associations. The above-mentioned documents can be accessed on <https://www.fufa.co.ug/fufa-ec-docs/>

**2. Register of all Club Officials**

FUFA EC informs all the stakeholders that a register of all DFA Club officials of District Football Associations that are actively playing 4<sup>th</sup> Division football, herein referred to as DFAs is accessible on the FUFA website <https://www.fufa.co.ug/fufa-ec-docs/> . All eligible persons who wish to participate in the DFA elections have up to 2359 Hours on 24<sup>th</sup> March 2025 to verify and update their respective particulars in the register.

### **3. FUFA Electoral Officers**

The FUFA Electoral Committee concluded the process of appointing and training all the Electoral Officers who shall assist the FUFA EC in the electoral process at DFA level. A list of all Electoral Officers of each DFA can be accessed on the FUFA website <https://www.fufa.co.ug/fufa-ec-docs/> . Football stakeholders at DFAs are encouraged to contact the Electoral Officer in their respective DFA for any assistance.

For purposes of the electoral process, the FUFA EC District Offices shall be located at the Local Government District Headquarters of the respective DFAs and in case of any variation of the location, the FUFA EC shall communicate accordingly.

### **4. Nomination of Candidates for DFA Elections**

Nomination of candidates for DFA elections shall be in accordance with the FUFA Electoral Guidelines, for purposes of clarity, all persons eligible for candidature in the DFA elections shall download nomination forms from the FUFA website <https://www.fufa.co.ug/fufa-ec-docs/>

ONLY duly completed forms accompanied with proof of payment and returned by the intending candidate in person shall be accepted by the FUFA EC Electoral Officer.

DFA nomination shall be available for download from this link <https://www.fufa.co.ug/fufa-ec-docs/> commencing on 25<sup>th</sup> March 2025 to 28<sup>th</sup> March 2025, and returning of the completed nomination forms shall be between 25<sup>th</sup> March 2025 up to 30<sup>th</sup> March 2025.


## **6. Polling day**
