Definitions

The use of these definitions shall only be limited to interpretation and application of the Guidelines

Referees: Shall mean current and former FUFA Registered Referees and Assistant Referees for all the forms of football thus 11-aside, FUTSAL and Beach Soccer

Players: Shall mean current and former FUFA Registered Players for all the forms of football thus 11-aside, FUTSAL and Beach Soccer

Ex-Internationals: shall mean only players who played for the Uganda Cranes Men's' National A Team in Africa Cup of Nations and FIFA World Cup Qualifiers and/or final competitions and shall also mean only players who played for the Crested Cranes Women's' National A Team in Africa Cup of Nations and FIFA World Cup Qualifiers and/or final competitions





General Provisions

Article 1 General Provisions

Time Schedules

- 1) The Time Schedules shall be as released by the EC and may only be altered by the EC. Electoral activities outside the scheduled time will be null and void

Nomination


- 2) The Nomination Fees as detailed in Annex-2 will be paid to the bank of the following details

Payment may be paid through Centenary Bank to the above-mentioned Bank Account.

- 3) With Written permission from the EC intending Candidates at the Level of DFA with difficulties to access the bank, may pay nomination fees on the Mobile Money to be provided by the FUFA EC and the following details shall be provided:
 - Mobile Money Number**
 - Registered Names**
- 4) Intending Persons to become candidates, for positions of the FUFA Elections, will request for banking slips from the FUFA EC.
- 5) The FUFA EC may only issue Banking Slips to intending Candidates,
- 6) Upon presentation of proof of payment, the FUFA EC will issue nomination forms to the intending Candidates.
- 7) The Intending candidate will thereafter submit the Nomination Forms in accordance with the FUFA EC schedules.
- 8) FUFA EC has the exclusive authority to schedule the return of nomination forms by intending Candidates. Candidates that do not follow their scheduled time of return of forms may be fined by the FUFA EC and nomination forms will not be received until the fine is paid and proof of payment is submitted to the FUFA EC. If scheduled nomination time elapses, nomination forms will not be accepted by the FUFA EC and if received will be considered NULL and Void.
- 9) Unless if prior special consideration is given by the FUFA EC, Nomination forms will be picked and returned by the intending candidates in person.

- 10) Due to the challenges established by a public health emergency like mpox, FUFA EC if deems fit may conduct sections of the nomination process and declaration of candidates using online systems.
- 11) The FUFA EC will vet the application of the intending Candidate and declare them Candidates if found compliant with the FUFA Statutes, FUFA Electoral Code, and these Guidelines.
- 12) Each member of an Elective General Assembly has one vote.
- 13) FUFA Elections will be by secret ballot.
- 14) The voting delegates representing an eligible entity or Club to vote in the FUFA Elections may be required by the FUFA EC to present a written authorization from the respective entity or Club.
- 15) Voting by Proxy is strictly prohibited.
- 16) If there are more Candidates than the vacant positions available for a FUFA Election, votes will be cast by the members of the elective Assembly and the top Candidate(s) with the biggest number **of votes** will be declared the winners. For avoidance of doubt, where applicable, the FUFA Statutes will override this provision.

Identification

- 17)
- Identification of persons against their names on the voter's register will require presentation of one of the following documents;
- Passport
 - Driving License
 - National Identity Card
 - FUFA Player License
 - Letter with a picture of the bearer from the LC1 of area of residence

Eligibility

- 18) For the 1st and 2nd Division men's league and FUFA Women's Super and FUFA Women's Elite leagues, only club representatives registered with FUFA for the 2024/2025 season shall be eligible to participate in the elections. For the 3rd and 4th Division leagues, club representatives registered with FUFA for the 2023/2024 and or 2024/2025 season may be eligible to participate in the elections.

19) The FUFA EC Will appoint Electoral Assistants or Returning Officers who will represent the FUFA EC at the FUFA Election

20) The FUFA EC will issue administrative, housekeeping rules and voting procedure details at the voting venue not in contravention with the FUFA Statutes, FUFA Electoral Code and these Guidelines

21) Only the FUFA EC will declare the winners

Voting

22) The list of eligible voters in accordance with the FUFA Statutes, FUFA Electoral Code, and these Guidelines will be established with Names and the total number of voters shall be declared before the commencement of the voting

23) Facilitated by the FUFA EC, a declaration motion will be passed that the composition and list of voters compiled is correct and in accordance with the FUFA Statutes, FUFA Electoral Code, and these Guidelines

24) The voting procedure will be as follows;

- a) FUFA EC will call one voter at a time to receive a ballot
- b) He/she will proceed to the booth to tick or thumb print the ballot
- c) No Cameras or Phones will be allowed into the voting booth
- d) The voter will thereafter move to place the ticked ballot in the urn
- e) After the final voter has cast his/her vote, the FUFA EC will count and tally the votes
- f) A declaration form will be signed by the FUFA EC which will include provisions for;
 - i) Total Votes
 - ii) Votes Cast
 - iii) Votes per Candidate
 - iv) Invalid Votes
- g) Total Votes = Votes to Candidates + Invalid Votes+ Unissued votes

25) Where the FUFA Statutes, FUFA Electoral Code, and these Guidelines are silent, the Chairman of the FUFA EC in consultation with the members of the FUFA EC will take a decision

District Football Associations Elections

Article **2** District Football Associations Elections

- 1) The FUFA EC Returning Officer will operate a desk at the respective District Headquarters or a place designated and communicated by the FUFA EC
- 2) There will be 3 sets of elections at each DFA;
 - a) Election of SIG Delegates to the DFA and SIG Regional Assembly
 - b) Election of the Executive Committee of the DFA
 - c) Election of Delegates to the RFA Assembly

Election of SIG Delegates to the DFA and Regional SIG Assembly.

- 3) The following persons will be elected to represent the respective SIG at the DFA Assembly and Regional SIG;

a) 3 representatives of Referees

- i) FUFA Registered Referees and Assistant Referees, Former FUFA Referees and Former FUFA Assistant Referees in the respective DFA shall comprise the Elective Assembly in the respective DFA.
- ii) From the elective assembly they will vote 3 representatives to the Regional Referees Association and DFA Assembly with at least one elected representative being a woman.

b) 3 representatives of Coaches

- i) Each FUFA Registered Coach of each of the 4th Division League Club will comprise the elective assembly in the respective DFA
- ii) From the elective assembly they will vote 3 representatives to the Regional Coaches Association and DFA Assembly with at least one elected representative being a woman.

c) 3 Representatives of Players

- i) Each FUFA Registered Football Club in respective DFA will nominate one player in writing to the FUFA EC from among the FUFA registered players with the respective DFA Club preferably a captain of a club. The nominated players will comprise elective assembly





From the elective assembly they will vote 3 representatives to the Regional Players' Association and DFA Assembly with at least one elected representative being a woman.

d) **3 Representatives of Schools**

- i) Each District primary Schools Sports Associations that intend to participate in FUFA Elections shall submit to the FUFA EC one delegate and Each District Secondary Schools Sports Associations that intend to participate in the FUFA Elections shall submit to the FUFA EC two delegates. On the two delegates at least, one shall be a Woman. The letter forwarding the delegates shall be signed by the Chairperson and Secretary of the Association at the District level.
- ii) The Delegates forwarded from primary and Secondary District Associations shall comprise the elective assembly to elect three delegates to the Regional Schools F.A.
- iii) Every DFA will elect one delegate from each District primary Schools sports Associations and two delegates from each District Secondary Schools sports Associations of who at least one delegate shall be a woman from the Elective Assembly to the RSFA Assembly.


Election of Executive Committee of the District Football Associations

- 4) The Elective Assembly for this election will compose of;
 - a) 3 Club Delegates from each of the 4th Division League Club
 - b) 3 representatives of Referees as elected in accordance with article 2 par 3
 - c) 3 representatives of Coaches as elected in accordance with article 2 par 3
 - d) 3 representatives of Players as elected in accordance with article 2 par 3
 - e) 3 representatives of the district schools' sports Associations
- 5) In each category in Article 2 par 4 of representatives, at least one shall be a woman.
- 6) The FUFA EC will issue nomination forms at the venue of election or as directed by the EC
- 7) The intending Candidate for the position of the Chairman of the DFA will submit proof of payment of nomination fees together with a list of intending candidates for the executive committee bearing the respective signature of each intending candidate
- 8) Election will be conducted in accordance with article 1 of these Guidelines

Election of Delegates Representing DFAs to the RFA Assembly

- 9) Only 4th Division League Clubs will participate in election of Delegates of the DFA to the RFA Assembly

10) Not more than 3 persons may represent a 4th Division club at the DFA Elective General Assembly where at least one is a woman.

- 11) Every 4th Division Club that intends to participate in the FUFA Elections shall submit to the FUFA EC a list of at least 3 Delegates from the Club to the DFA Elective General Assembly. At least 1 of the 3 Delegates shall be a woman.
- 12) 2 of the 3 club delegates must be amongst the Club officials registered with FUFA while the woman delegate may not be a registered official of the nominating Club
- 13) Only Members of the Elective General Assembly may vote and/or may be voted as delegates to the RFA Assembly representing the DFA
- 14) Every DFA will elect 3 Delegates, of whom at least one delegate shall be a woman, from the Elective Assembly to the RFA Assembly.
- 15) Election procedure will be conducted in accordance with article 1 of these Guidelines

Regional Football Associations Elections


Article **3** Regional Football Associations Elections

- 1) The FUFA EC Returning Officer will operate a desk at Regional Football Association Headquarters or a place designated and communicated by the FUFA EC
- 2) There will be 4 sets of elections conducted in this order;
 - a) Election of (1) 3rd Division League Representative Delegate to the FUFA General Assembly
 - b) Election of SIG Delegates to the National SIG Assemblies and RFA Assemblies
 - c) Election of (5) DFA Representative Delegates to the FUFA General Assembly
 - d) Election of the Executive Committee of the RFA

Election of 3rd Division League Clubs Delegates to the FUFA General Assembly

- 3) Every 3rd Division Club that intends to participate in the FUFA Elections shall submit to the EC 1 Club Delegate to the 3rd Division League Elective General Assembly. These club delegate shall be amongst the Club officials registered with FUFA
- 4) Only 3rd Division League Clubs will participate in election of Delegates of the 3rd Division League Club to the FUFA General Assembly
- 5) Only Members of the Elective General Assembly may vote and/or may be voted

Every RFA will elect 1 Delegate from 3rd Division League Elective Assembly to the FUFA General Assembly

Election of SIG Delegates to the National SIG Assemblies and RFA Assemblies

7) The following persons will be elected to represent the respective Regional SIG to National SIG Assembly and RFA Assemblies.

a) Referees

- i) The 3 Referees Delegates from each DFA that comprise the respective RFA will comprise the elective assembly to elect representatives to UFRA General Assembly and to the RFA General Assembly
- ii) Only Members of the Elective General Assembly may vote and/or may be voted as representatives to the UFRA Assembly and to the RFA General Assembly
- i) 3 persons where at least 1 is a woman will be voted as representatives to the UFRA General Assembly. 1 of the 3 elected representatives with the highest number of votes will be the representative to the respective RFA general Assembly.

b) Coaches

- i) The elective assembly to elect representatives to UFCA General Assembly and to the RFA General Assembly shall be composed of the following;
 - a. 3 Coach Delegates from each DFA that comprise the respective RFA
 - b. 1 Coach Delegate from each of the 3rd Division League Club of the RFA
 - c. 1 Coach Delegate from each of the Women Football Club of the RFA
- ii) Only Members of the Elective General Assembly may vote and/or may be voted as representatives to the UFCA Assembly and to the RFA General Assembly
- iii) 3 persons where at least 1 is a woman will be voted as representatives to the UFCA General Assembly. 1 of the 3 elected representatives with the highest number of votes will be the representative to the respective RFA general Assembly.

c) Players

- i) The elective assembly to elect representatives to UFPA General Assembly and to the RFA General Assembly shall be composed of the following;
 - a) Player Delegates from each DFA that comprise the respective RFA
 - b) 1 Player Delegate from each of the 3rd Division League Club of the RFA
 - c) 1 Player Delegate from each of the Women Football Club of the RFA





ii) Only Members of the Elective General Assembly may vote and/or may be voted as representatives to the UFPA Assembly and to the RFA General Assembly

iii) 3 persons where at least 1 is a woman will be voted as representatives to the UFPA General Assembly. 1 of the 3 elected representatives with the highest number of votes will be the representative to the respective RFA general Assembly.

d) Women Football

- i) Only Regional Women League Clubs will participate in election of Delegates to the Regional Women FA General Assembly
- ii) Not more than 3 persons who are FUFA Registered Club Officials, where at most 1 is a man, may represent a Regional Women League Club at the Regional Women Football Association General Assembly
- iii) The Regional Women Football Association General Assembly shall be the elective assembly for the election of representatives of Regional Women Football Association to the UWFA General Assembly and to the RFA General Assembly.
- iv) Only Members of the Elective General Assembly may vote and/or may be voted as representatives to the UWFA Assembly and to the RFA General Assembly
- v) 3 persons where at most 1 is a man will be voted as representatives to the UWFA General Assembly. 1 of the 3 elected representatives with the highest number of votes will be the representative to the respective RFA general Assembly.

e) Youth Football

- i) Only FUFA Registered Academies will participate in election of Delegates to the Regional Youth FA General Assembly
- ii) 2 of the 3 club delegates must be amongst the Academy Officials registered with FUFA while the woman delegate may not be a registered official of the nominating Club
- iii) The Regional Youth Football Association General Assembly shall be the elective assembly for the election of representatives of Regional Youth Football Association to the UYFA General Assembly and to the RFA General Assembly.
- iv) Only Members of the Elective General Assembly may vote and/or may be voted as representatives to the UYFA Assembly and to the RFA General Assembly





- v) 3 persons where at least 1 is a woman will be voted as representatives to the UYFA General Assembly. 1 of the 3 elected representatives with the highest number of votes will be the representative to the respective RFA general Assembly.

f) Schools Football

- i) The elective assembly to elect representatives to USFA General Assembly and to the RFA General Assembly shall be composed of the following;
- ii) 1 Delegate from the District primary Schools sports Associations
- iii) 2 delegates from the District Secondary Schools sports Associations where at least one delegate is a Woman
- iv) Only members of the Elective General Assembly may vote and or may be voted as representatives to the USFA Assembly and to the RFA General Assembly
- v) 1 person from primary Schools Section and two from Secondary Schools section will be voted as representatives to the USFA General Assembly. Of the two from the Secondary Schools Section at least one shall be a Woman. One of the 3 elected Representatives with the Highest number of Votes would be the Representative to the respective RFA General Assembly

Election of DFA Delegates representing RFA to the FUFA General Assembly

- 8) Only Delegates representing DFAs of the 4th Division League Clubs will constitute this elective assembly
- 9) Only Members of this Elective General Assembly may vote and/or may be voted
- 10) Every RFA will elect 5 Delegates from this Elective Assembly to the FUFA General Assembly.
- 11) The 1 delegate representing the respective RFA 3rd division league clubs elected as stipulated in Article 3 par 6 of these guidelines and 5 delegates representing DFA elected as stipulated in Article 3 par 10 of these guidelines shall compose the 6 Delegates representing the respective RFA to the FUFA General Assembly
- 12) Of the 6 delegates representing RFA to FUFA General Assembly, at least 1 delegate shall be a woman subject to the FUFA Statutes.
- 13) In compliance with the FUFA Statutes, RFAs composed of more than 1 Province Football Association, each province shall be represented with at least 1 delegate to the FUFA General Assembly.

Election of the Executive Committee of the RFA

- 14) These elections will be conducted after election of the Delegates representing the respective RFAs to the FUFA General Assembly

- 15) The Elective Assembly for this election will compose of;
 - a) 3 DFA Delegates from each DFA comprising the RFA
 - b) 1 FUFA Registered Club Official from each of the 3rd Division League Clubs
 - c) 1 FUFA Registered Club Official from each of the Regional Women Football League Clubs
 - d) The Elected Representative of the Referees to the Regional Football Association Assembly
 - e) The Elected Representative of the Players to the Regional Football Association Assembly
 - f) The Elected Representative of the Coaches to the Regional Football Association Assembly
 - g) The Elected Representative of Women Football to the Regional Football Association Assembly
 - h) The Elected Representative of Youth Football to the Regional Football Association Assembly
 - i) The Elected Representative of Schools Football to the Regional Football Association Assembly

- 16) The intending Candidate Chairman will submit proof of payment of nomination fees together with a list of intending candidate executive committee members bearing the respective signature of each member

- 17) Matters not provided and not in contravention with the FUFA Statutes, FUFA Electoral Code and these guidelines shall be determined in accordance with the respective RFA Constitutions as approved by FUFA and Registered with FUFA.

Elections of SIGs Delegates to FUFA General Assembly

Article **4** Elections of SIGs Delegates to FUFA General Assembly


Uganda Football Referees Association

- 1) The Elective Assembly for this election will compose of;
 - a) 3 RFA Referees' Representatives from each of the 8 RFA to UFRA
 - b) Each of the 2025 International Referees and Assistant Referees
 - c) 10 FUFA Licensed Referee Assessors elected by and from amongst themselves.
- 2) Only Members of this Elective General Assembly may vote and each member has 1 vote
- 3) Only FUFA Licensed Assessors and fully subscribed members of the UFRA are eligible to stand for election
- 4) 3 persons where at least 1 is a woman will be voted as representatives of UFRA to the FUFA General Assembly

Uganda Football Coaches Association

- 5) The Elective Assembly for this election will compose of;
 - a) 3 RFA Coaches' Representatives from each of the 8 RFA to UFCA
 - b) 1 FUFA Registered Coach nominated by each of the 16 UPL Clubs
 - c) 1 FUFA Registered Coach nominated by each of the FUFA Big League Club
 - d) 1 FUFA Registered Coach nominated by each of the FUFA Women Super League Club
 - e) 1FUFA Registered Coach nominated by each of the FUFA Women Elite League Club
 - f) 1 FUFA Registered Coach nominated by each of the 1st Division Beach Soccer men league Club
 - g) 1 FUFA Registered Coach nominated by each of the Futsal Association of Uganda
- 6) Each member of this Elective General Assembly has one vote
- 7) Only Members elected from RFA or nominated in writing to the FUFA EC shall participate in this Elective General Assembly to vote
- 8) The 1st and 2nd Division nominated representatives shall present proof of subscription to the UFCA
- 9) Only FUFA Licensed Coaches and fully subscribed members of the UFCA are eligible to stand for election
- 10) 2 persons will be voted as representatives of UFCA to the FUFA General Assembly

- 11) The Elective Assembly for this election will compose of;
 - a) 3 Representatives from each of the RFA
 - b) 1 delegate from each of the FWSL Clubs
 - c) 1 delegate from each of the FWEL Clubs
 - d) 1 delegate from the Beach Soccer Women League.
- 12) Only women may be elected to represent the UWFA to the FUFA General Assembly
- 13) Only Members of this Elective General Assembly may vote and each member of this Elective General Assembly has one vote
- 14) 2 persons will be voted as representatives of UWFA to the FUFA General Assembly

Uganda Youth Football Association

- 15) The Elective Assembly for this election will compose of 3 RFA Youth Football Representatives from each of the 8 RFA
- 16) Only Members of this Elective General Assembly may vote and each member of this Elective General Assembly has one vote
- 17) 2 persons will be voted as representatives of UYFA to the FUFA General Assembly

Uganda Football Players Association.

- 18) The Elective Assembly for this election will compose of;
 - a) 3 RFA Players' Representatives from each of the 8 RFA to UFPA
 - b) 1 Registered Player nominated in writing by each of the 1st Division Club
 - c) 1 Registered Player nominated in writing by each of the 2nd Division Club
 - d) 1 Registered Player nominated in writing by each of the FWSL Club
 - e) 1 Registered Player nominated in writing by each of the FWEL Club
 - f) 1 Registered Player nominated in writing by each of the Men Beach Soccer League Club
 - g) 1 Registered Player nominated in writing by each of the Futsal league club
 - h) 10 Former players determined as stipulated in Art 4 par 19 of these guidelines
- 19) The Former FUFA registered Players shall elect or select from amongst themselves 5 persons, where at least 1 is a woman and the Ex-internationals shall elect or select from amongst themselves 5 persons where at least 1 is a woman to the UFPA Assembly
- 20) Only Members of this Elective General Assembly may vote and each member of this Elective General Assembly has one vote





21) Only Former Players of Ugandan Nationality may be elected to represent the UFPA to the FUFA general Assembly

22) 2 persons will be voted as representatives of UFPA to the FUFA General Assembly

Uganda Schools Football Association

23) The Elective Assembly for this election will compose of;

- a) 1 Representative from each of the RFA representing the Primary Schools Sports Associations
- b) 2 Representatives from each of the RFA Secondary Schools Sports Association with at least one being a woman.

24) Only members of this Elective Assembly may vote and may be voted, each member of this Elective assembly has one vote.

25) 2 persons will be voted as representatives of USFA to the FUFA General Assembly.

Uganda Beach Soccer Association

26) The Elective Assembly for this election will compose of;

- a) 3 Representatives, where at least 1 is a woman, from each of the UBSA 1st Division League Clubs
- b) 3 Representatives, where at least 1 is a woman, from each of the UBSA 2nd Division League Clubs

27) Only FUFA Registered UBSA Club Officials may participate in the elections

28) Only Members of this Elective General Assembly may vote and each member of this Elective General Assembly has one vote

- 2) Only Members of this Elective General Assembly may vote and each member of this Elective General Assembly has one vote
- 3) 5 persons will be voted as representatives of FBL Clubs to the FUFA General Assembly

Article **8** Elections of the 3rd FUFA vice president

- 1) The Elective Assembly for this election will compose of;
 - a) 1 Representative from each of the 1st Division Clubs
 - b) 1 Representative from each of the 2nd Division Clubs
- 2) Only a letter signed by the President (or Chairman), known and registered by FUFA, of the 1st or 2nd Division Club shall be accepted as a delegation of the Club Voting authority to the bearer. Only FUFA registered Club Officials may be delegated to represent the club in the elective assembly
- 3) Only 1st Division Clubs may nominate a candidate for the position of 3rd Vice President representing professional clubs to the FUFA Executive Committee
- 4) Only a letter signed by the President (or Chairman), known and registered by FUFA, of the 1st Division Club shall be accepted as a nomination of a candidate for the position of FUFA 3rd Vice President
- 5) Only Members of this Elective General Assembly may vote and each member of this Elective General Assembly has one vote
- 6) The 1st and 2nd Candidates after the vote count will be submitted to the FUFA General Assembly.
- 7) If the 1st Candidate is confirmed by a vote at the FUFA General Assembly, he will be declared the Winner by the FUFA EC. In event that the 1st Candidate is rejected by a vote, the 2nd Candidate will be subjected to a vote by the FUFA General Assembly and in event is confirmed the winner, He will be declared the winner by the FUFA EC. In event that he is rejected by vote, the procedure from Article 8 par 1 to par 7 will be repeated

Elections of the FUFA Executive Committee

Article 9 Elections of the FUFA Executive Committee

- 1) The Elective Assembly for this election will be the FUFA General Assembly;
- 2) The Eligibility for the candidates of the FUFA Executive Committee shall be strictly in accordance with the FUFA Statutes and the FUFA Electoral Code.
- 3) The intending Candidate for the position of the FUFA President will submit proof of payment of nomination fees together with a list of intending candidate executive committee members bearing the respective signature of each member
- 4) The 6 delegates representing the RFA to the FUFA General Assembly will elect among themselves one person who will be considered the chairman and another who will be considered the secretary of the RFA for **ONLY** the purposes of fulfilling article 10 (5) and 10(6) of the FUFA Electoral Code
- 5) For avoidance of doubt, in interpretation and application of article 10 (5) of the FUFA Electoral Code, FUFA Super League Clubs shall mean the 1st Division League Clubs
- 6) The Chairman of the FUFA EC will chair the proceedings of the election on the FUFA Executive Committee

Article 10 FUFA Electoral Guidelines

These FUFA Electoral Guidelines were adopted to operationalise the provisions of the FUFA Statutes and the FUFA Electoral Code and any provisions here that are in contravention with the FUFA Statutes and/or the FUFA Electoral Code are null and void. These Guidelines were adopted at the 33rd FUFA Executive Committee at Kampala, Kampala Region Football Association, on the 24th February 2025 and came into force on the same date


