## **RE: LETTER TO INTRODUCE OFFICIALS TO PARTICIPATE IN THE FUFA DFA ELECTIONS.**

The FUFA Electoral Committee would like to remind all District Football Association club officials that in accordance with the FUFA Electoral Guidelines 2025, All 4<sup>th</sup> Division clubs that appear on the final register and wish to participate in DFA elections are advised to comply with the following guidelines:-

1. To submit the three club officials to represent the club in the DFA Elections. **At least, one of the three officials must be a woman. In case there's no woman, only two officials will be permitted.** The male officials **must** have been registered by the club with FUFA and/or appear on the final register for 4<sup>th</sup> Division clubs as displayed on the FUFA website while the female official does not need to appear on the register. For clarity, a woman who appears in the final register published by FUFA shall take precedence.
2. To submit the player's name (preferably a captain) to represent players in the DFA players' elections. The Club shall attach the license used in the 4<sup>th</sup> Division league for the 2024-25 season. Only the player whose name is forwarded by the club shall be permitted to participate in the DFA electoral process.
3. To submit the name of a **FUFA registered Football Coach** who will represent the coaches in the coaches' elections. Only a coach whose name is forwarded by the club shall be permitted to participate in the DFA electoral process.

Only club officials submitted by the club in the above-mentioned form by 5:00 PM Friday, 4<sup>th</sup> April, 2025 in compliance with the FUFA Electoral Guidelines shall be **permitted to gain access to the voting area.**
