#### Nomination of candidates

ONLY duly filled forms returned by the intending candidate by **2359 Hours on 5<sup>th</sup> May 2025** shall be accepted by the FUFA Electoral Committee. The forms shall be accompanied by the following:

1. nomination letter from a 1<sup>st</sup> division club of the 2024/5 season
2. proof of payment

For purposes of clarification, pursuant to article 8 (4) of the FUFA Electoral Guidelines, only a letter signed by the President (or Chairman), known and registered by FUFA, of the 1<sup>st</sup> Division Club shall be accepted as a nomination of a candidate for the position of FUFA 3<sup>rd</sup> Vice President.


