During the year the Team has continually provided support services to the FUFA Secretariat and other Stakeholders at all FUFA premises including FUFA HQs, FUFA Paradise Hotel -Kisaasi, FUFA Technical Centre -Njeru; and more recently FUFA Stadium -Kadiba.

Human Resource

FUFA Secretariat staff headcount increased from 61 to 81 (24 female and 57 male) during the year. Most of the new staff are in the Football Development Department as part of the implementation of FUFA Technical Master Plan (TMP).

FUFA takes health insurance as fundamental to staff and stakeholders' welfare, and the insurance policy cover is currently under review to enhance the value proposition to the beneficiaries.

The Human Resource Team has also facilitated a convenient platform for Secretariat staff and other stakeholders to renew and acquire National identification cards by liaising with NIRA to set up a National ID Registration Centre at FUFA HQs.

The office’s dedication ensures legal protection and compliance in commercial, intellectual property, corporate and litigation matters, while also overseeing judicial bodies and safeguarding the integrity of football.

The Office has also been instrumental in ensuring FUFA’s full compliance with FIFA, CAF, and FUFA Statutes, brand identity guidelines and internal regulations.

The key achievements include:

Corporate Legal Compliance & Growth

- **Statutory Amendments:** Collaborated with the Rules Review Commission to prepare and present FUFA Statutes amendments, successfully approved by the FUFA Executive Committee.
- **Legal Protection of FUFA Properties:** Registered all FUFA immovable and movable assets with government offices.
- **Governance support to Member Associations:** Assisted Regional Football Associations and Special Interest Groups in updating their statutes, streamlining governance and compliance.
- **FUFA legal Entities Compliance & Brand Protection:** Ensured adherence to National laws and internal compliance for FUFA’s four legal entities; FUFA Media Services Ltd, FUFA Sportware Ltd, FUFA Hospitality and Travel Agency Ltd, etc.

Commercial Legal Safeguards

- **Contractual Excellence:** Prepared, drafted and analysed over 15 contracts with partners and service providers, ensuring FUFA’s commercial interests are legally secured.

Litigation Management & Reduction



This achievement significantly reduced risks and legal costs for FUFA, primarily due to compliance with National laws and the Legal office’s guidance in decision-making processes.

Intellectual Property Protection

Protecting FUFA’s valuable brands remains a top priority, with the Legal Office ensuring:

- **Trademark Registration:** All FUFA trademarks are up-to-date with the Uganda Registration Services Bureau (URSB), with over ten official trademarks of FUFA and its legal entities successfully renewed.
- **Enforcement & Awareness:** Ongoing sensitisation efforts and prosecution of infringers continue to protect FUFA’s intellectual property.

Protecting Football Integrity

FUFA promotes integrity and safeguards football matches through education, investigation, and collaboration with external bodies to combat match manipulation.

Awareness and Education

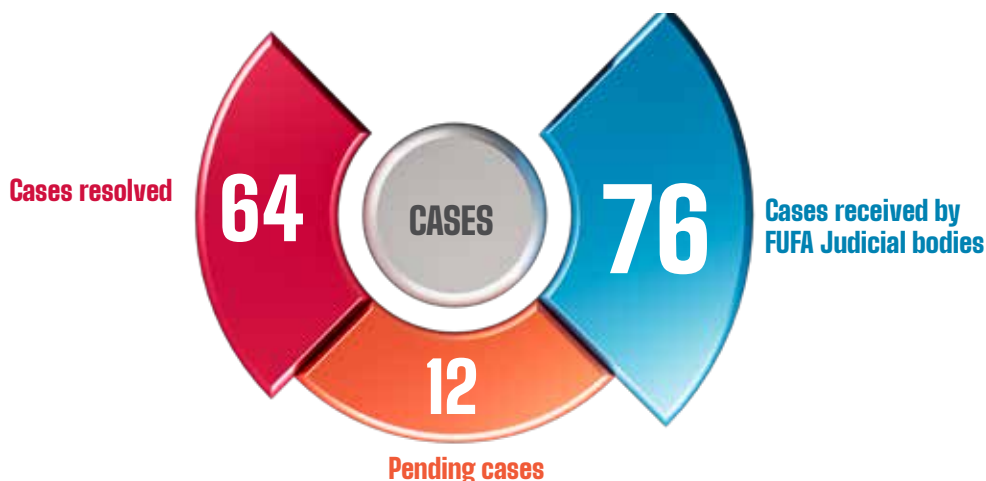

Stakeholder Engagements: FUFA collaborated with the Uganda Police Force and the Office of the Director of Public Prosecutions to enforce laws against match manipulation.

Investigation and Sanctioning: FUFA actively investigates and sanctions match-fixing offenders, exemplified by the Adjudicatory Chamber's ban of 12 individuals, including one lifetime ban, on November 26, 2024.

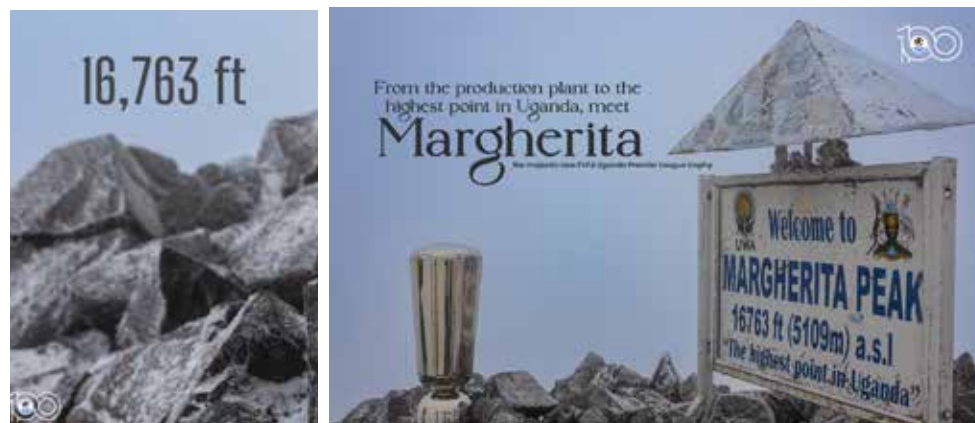

Infrastructure Projects



FUFA Projects Manager Sumaya Kiwanuka

Since the last General Assembly in 2024 at Maya, FUFA has focused on:

FUFA Lugazi Stadium

Secured and maintained the land donated to FUFA by the Buganda Kingdom for future development, with plans to construct a 20,000-seater stadium. Ongoing efforts include landscaping and protecting the land against encroachers.

FUFA Technical Centre, Njeru

Upgraded the facility with a new artificial turf, enabling it to host top-level matches, thanks to a successful partnership with BUL FC. As one of FUFA's member clubs, BUL FC currently utilises the facility as their home ground in both the Uganda Premier League and FUFA Juniors League.

FUFA Kadiba Technical Centre and Stadium

Kadiba Stadium has been a key focus area for FUFA since the 2024 AGM, thanks to funding from the FIFA Forward Programme. The facility will serve as a designated training ground for CHAN 2024 and PAMOJA AFCON 2027, and is set to be handed over to CAF by July 15th for CHAN 2024 preparations.

To secure the facility from encroachment, FUFA acquired additional land adjacent to the stadium using \$460,600 from the FIFA Forward Programme. This purchase increased the total land area to approximately 6.4 acres.

The ongoing project has made significant progress, including the construction of a pavilion's foundation and substructure, upgraded floodlights meeting CAF standards, installation of a standby generator, natural playing turf, office space, stadium seating, and dressing rooms. Other completed works include perimeter fencing, security lighting, and access road improvements in partnership with KCCA.

Work on Pavilion 1 is also underway, with plans to upgrade the stadium further. Looking ahead, our vision for Phase 3 includes increasing the seating capacity to 20,000, completing the second set of dressing rooms, extending land procurement, and building a hostel for accommodation.

FIFA Club Professionalisation and Management Programme

After its successful launch at Golden Tulip in Kampala in 2024, the programme has been delivering sessions through both physical and online platforms. Participating clubs were tasked with submitting strategic plans, with the most

comprehensive one earning an all-expenses-paid trip to the FIFA Club World Cup in the USA.

FUFA President Hon. Magogo Moses Hassim congratulated URA FC on their historic recognition by FIFA for submitting the winning strategic plan, which focused on nurturing talent for sustainable development.

The plan emphasised developing players from grassroots to life after football, achieving governance, business, and sport pyramid goals by balancing four key perspectives: financial, internal processes, stakeholders, learning, and growth.

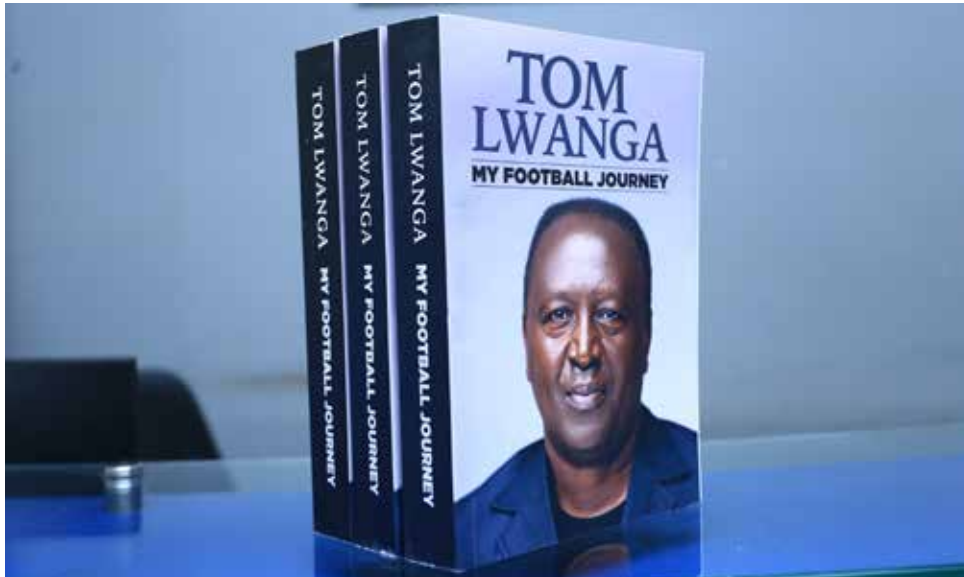
El Hadji Diouf visit to Uganda

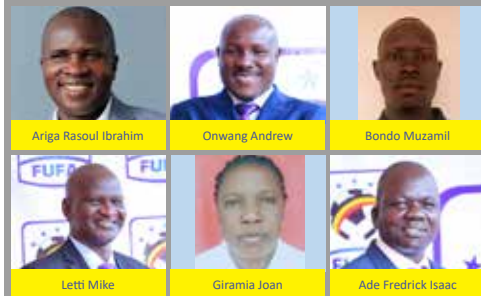

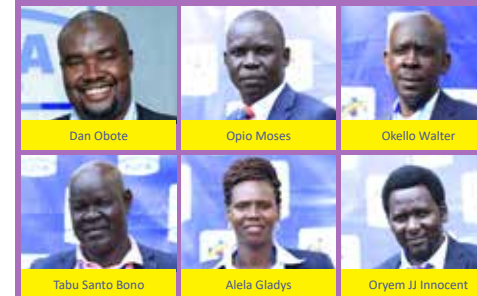
