The Club confirms that, prior to completing and executing this Form, it has read, reviewed, and taken all necessary steps to understand the FUFA Club Licensing Regulations 2026, a copy of which is uploaded on the FUFA website. whether independently or through duly appointed legal adviser and that it is ready, willing, and committed to full compliance therewith.
4. By completing, and submitting this Form, the Club hereby formally declares its interest in participating in the FUFA Competitions 2026/2027 season.
5. The Club acknowledges and accepts the authority and jurisdiction of the FUFA Club Licensing Committee (the composition of which is appended hereto) as the competent first-instance decision-making body in all club licensing matters, and of the FUFA Club Licensing Appeals Committee as the competent appellate and final body with respect to any appeals arising therefrom.
6. The Club undertakes to respect, comply with, and be bound by the decisions of the aforementioned bodies. The Club expressly declares that it shall not refer, submit, or seek recourse in respect of any club licensing matter, dispute, or decision before any civil court of law, but shall instead submit exclusively to the dispute resolution mechanisms established under the applicable FUFA, CAF, and FIFA statutes and regulations.
7. The Club undertakes to strictly observe all club licensing deadlines, timelines, notices, communications, and requirements as communicated by FUFA, including through the official club email address provided in this Form.
8. The Club fully understands and acknowledges that failure to duly complete, execute, and return this Expression of Interest Form to FUFA within the prescribed timelines shall be deemed conclusive evidence that the Club has declined to participate, or does not intend to participate, in the FUFA Competitions 2026/2027 season.
