DEFINITIONS

The terms given below denote the following:

Arbitration Tribunal: private court of justice acting instead of an Ordinary Court.

Association: a football Association recognised as such by FUFA, it is a Member of FUFA, unless a different meaning is evident from the context.

Association football: the game controlled by FIFA and its members and organised in accordance with the Laws of the Game.

Association Football Laws; the Statutes, Regulations, Decisions and Directives of FUFA, CAF and FIFA

CAS (TAS): Court of Arbitration for Sport (Tribunal Arbitral du Sport) in Lausanne (Switzerland)

Club: A football club registered with and licensed by FUFA

Confederation: a group of Associations recognised by FIFA and belonging to the same continent (or similar geographic area).

Executive Committee: the executive body of FUFA.

FIFA: Fédération Internationale de Football Association.

Football Competitions; football match or matches organised by FUFA or a delegated entity in accordance with FUFA Rules

FUFA: Federation of Uganda Football Associations.

General Assembly: the supreme body of FUFA.

IFAB: The International Football Association Board.

League: a collection of teams playing in a football competition organized by FUFA or an entity authorized by FUFA as detailed by respective competition regulations approved by FUFA.

Member: an association or club or league that has been admitted into membership of FUFA by the General Assembly.

Officials: all board members, committee members, coaches, referees, assistant referees, referee assessors, match commissioners and attendants as well as other people responsible for technical, medical and administrative matters at FIFA, CAF, FUFA, League, club or FUFA delegated and licensed entities.

Ordinary Courts: state courts which hear public and private legal disputes.

Player: a football player registered with FUFA or another FIFA Member Association

Professional Leagues: the 1st and 2nd Division Leagues of Men and the 1st Division League of Women

Promotion: when a club attains the right, subject to club licensing, to play in a higher league level than the one it played in the previous season

Regional Association: a member of FUFA in charge of association football in an area of defined geographical boundaries

Relegation: when a club loses the right, subject to club licensing, to play in the same league level like the one it played in the previous season

UOC: Uganda Olympic Committee.

NB: References to natural persons include both genders. The singular case applies to the plural and vice-versa.

GENERAL PROVISIONS

I. GENERAL PROVISIONS

1 Name, headquarters, legal form

1.

The name of the Organisation is FEDERATION OF UGANDA FOOTBALL ASSOCIATIONS (abbreviated and herein after referred to as "FUFA")

2.

FUFA is a private body Corporate registered under the National Sports Act Cap 151 as the monopoly regulators and managers of the sport of football in the territory of Uganda.

3.

FUFA is a private organization of an associative nature comprised of its members as listed in article 10 of these Statutes.

4.

The headquarters of FUFA are in Mengo Kampala.

5.

FUFA is a Member of FIFA, CAF, CECAFA and UOC

6.

The FUFA flag is a white rectangle featuring the FUFA logo at its centre.

7.

The emblem and Logo of FUFA is an image of a ball made of pentagon patches of black and white with a ribbon around the ball comprised of Black, Yellow and Red. The image also has five blue stars and the word FUFA in blue. There is also the phrase since 1924. All that is enclosed by blue boundaries.

8.

The flag, emblem, logo, slogan and abbreviation are legally registered with the Registrar of Trademarks for the territory of Uganda.

2 Objectives

1.

The objectives of FUFA are:

- a) To improve the game of football constantly and promote, regulate and control it throughout the territory of Uganda in the light of fair play and its unifying, educational, cultural and humanitarian values, particularly through youth and development programmes;

GENERAL PROVISIONS

- b) To organise competitions in Association Football in all its forms at a national level, by defining precisely, as required, the areas of authority conceded to the various Leagues of which it is composed;
- c) To draw up regulations and provisions and ensure their enforcement;
- d) To protect the interests of its members;
- e) To respect and prevent any infringement of the statutes, regulations, directives and decisions of FIFA, of CAF and FUFA as well as the Laws of the Game and to ensure that these are also respected by its members;
- f) To promote integrity, ethics and fair play with a view to preventing all methods or practices, such as corruption, doping or match manipulation, which might jeopardise the integrity of matches, competitions, Players, Officials and Members or give rise to abuse of Association Football, futsal or beach soccer;
- g) To control and supervise all friendly football matches of all forms played throughout the territory of FUFA;
- h) To manage international sporting relations connected with Association Football in all its forms;
- i) To host competitions at international and other levels;

3 Neutrality and non-discrimination

1.

Discrimination of any kind against a Country, private person or group of people on account of race, skin colour, ethnic, national or social origin, sex, gender, language, religion, political opinion or any other opinion, wealth, birth, sexual orientation or any other status, or any other reason is strictly prohibited and punishable by suspension or expulsion and/or disciplinary measures.

2.

FUFA remains neutral in matters of politics and religion.

4 Promoting friendly relations

1.

FUFA shall promote friendly relations between its Members, Clubs, Officials and Players and in society for humanitarian objectives.

2.

Every person and organisation involved in the game of football is obliged to observe the Statutes, Regulations and the principles of fair play as well as the principles of loyalty, integrity and sportsmanship.

3.

FUFA shall provide the necessary institutional means to resolve any internal dispute that may arise between Members, Clubs, Officials and Players.

GENERAL PROVISIONS

5 Players

1.
The status of Players and the provisions for their transfer shall be regulated by the Executive Committee of FUFA in accordance with the current FUFA Regulations for the Status and Transfer of Players.
2.
Players shall be registered in accordance with the Regulations of FUFA.

6 Laws of the Game

1.
FUFA and each of its Members shall play association football in compliance with the Laws of the Game issued by IFAB. Only IFAB may lay down and alter the Laws of the Game.
2.
FUFA and each of its Members shall play futsal and beach soccer in accordance with the Futsal Laws of the Game and the Beach Soccer Laws of the Game. Only FIFA may lay down and alter the Futsal Laws of the Game and the Beach Soccer Laws of the Game

7 Conduct of Bodies and Officials

1.
The bodies and Officials of FUFA must observe the Statutes, Regulations, Directives, Decisions and the Code of Ethics of FIFA, of CAF and of FUFA in their activities.
2.
Every person and organisation involved in the game of football is obliged to observe the Statutes and regulations of FIFA, CAF and FUFA as well as the principles of fair play.

8 Official languages

1.
The official language of FUFA shall be English. Official documents and texts shall be written in the English language.
2.
The official language at the General Assembly shall be English.

II. MEMBERSHIP

9 Admission, suspension and expulsion

1. The General Assembly shall decide whether to admit, suspend or expel a Member.
2. Admission may be granted if the applicant fulfils the requirements of FUFA.
3. Membership is terminated by resignation or expulsion. Loss of membership does not relieve the Member from its financial obligations towards FUFA or other Members of FUFA but leads to the loss of all rights in relation to FUFA.

10 Admission

1. The Ordinary Members of FUFA are:
 - 1 Each of the FUFA Licensed 1st Division Clubs;
 - 2 Each of the Regional Football Associations (RFAs);
 - 3 Each of the FUFA Special Interest Groups
 - 4 The 2nd Division League;
 - 5 The National Women Football Leagues
2. Only entities that have fulfilled the admission and obligatory requirements of these statutes shall exercise their membership rights:
3. The 8 RFAs shall be composed as follows;
 - 1) West Nile RFA
West Nile Province Football Association
 - 2) Kampala RFA:
Kampala Province Football Association
 - 3) Buganda RFA
Buganda Province Football Association
 - 4) Northern RFA
 1. Acholi Province Football Association
 2. Lango Province Football Association
 - 5) North Eastern RFA
 1. Karamoja Province Football Association

MEMBERSHIP

2. Sebei Province Football Association
3. Teso Province Football Association
- 6) Western RFA
 1. Ankole Province Football Association
 2. Kigezi Province Football Association
- 7) Kitara RFA
 1. Bunyoro Province Football Association
 2. Rwenzori Province Football Association
 3. Tooro Province Football Association
- 8) Eastern RFA
 1. Bukedi Province Football Association
 2. Bugisu Province Football Association
 3. Busoga Province Football Association

4.

The FUFA Executive Committee may issue special regulations to define territorial boundaries of the Province and District Football Associations.

5.

The FUFA Special Interest Groups shall include;

1. The FUTSAL Association of Uganda
2. The Uganda Beach Soccer Association
3. The Uganda Football Coaches Association
4. The Uganda Football Players Association
5. The Uganda Football Referees Association
6. The Uganda Schools Football Association
7. The Uganda Women Football Association
8. The Uganda Youths Football Association

6.

The FUFA 1st Division Clubs shall automatically lose membership upon failure to obtain a FUFA Club License

7.

Clubs Promoted to the FUFA 1st Division League shall not gain Membership to FUFA until their application has been processed in accordance with these Statutes.

8.

The Associate Members of FUFA are:

- a) The Uganda National Universities Football Association;
- b) The Uganda Tertiary Institutions and Colleges Football Association;

9.

The Associate Members may take part in the General Assembly but are not entitled to vote.

10.

Any Association, Club or League wishing to become a Member of FUFA shall apply in writing to the general secretariat of FUFA.

11.

The application must be accompanied by the following mandatory items:

- a) A copy of its legally valid Statutes and Regulations;
- b) A declaration that it will always comply with the Statutes, regulations and decisions of FUFA, FIFA and CAF and ensure that these are also respected by its own Members, Clubs, Officials and Players;
- c) A declaration that it will comply with the Laws of the Game in force;
- d) A declaration that during its membership shall not take disputes, matters of interpretation and application of the FIFA, CAF and FUFA Statutes, Regulations, decisions and directives to Ordinary Courts of law.
- e) A declaration that it recognises the, Arbitration Court of Sport in Uganda and the Court of Arbitration for Sport (CAS) in Lausanne, as specified in these Statutes;
- f) A declaration that it is located and registered [if legally required] in the territory of Uganda;
- g) A declaration that it will play all official home matches in the territory of Uganda;
- h) A declaration to the effect that the legal composition of the applicant guarantees that it can make decisions independently of any external entity;
- i) A list of Officials, specifying those who are authorised signatories with the right to enter into legally binding agreements with third parties;
- j) A declaration that it undertakes to organise or participate in friendly matches only with the prior consent of FUFA;
- k) A copy of the minutes of its last General Assembly or constitutional meeting;

11 Request and procedure for application

1.

The Executive Committee shall request the General Assembly either to admit or not to admit an applicant. The applicant may state the reasons for its application to the General Assembly.

2.

The new Member shall acquire membership rights and duties as soon as it has been admitted.

12 Member Associations' rights

1.

The Member Association of FUFA have the following rights:

- a) To take part in the General Assembly of FUFA, to know its agenda in advance, to be called to the General Assembly within the prescribed time and to exercise their voting rights;
- b) To draw up proposals for inclusion in the agenda of the General Assembly;

MEMBERSHIP

- a) To nominate candidates for all bodies of FUFA to be elected;
- b) To be informed of the affairs of FUFA through the official bodies of FUFA;
- c) To take part in competitions [if applicable] and/or other sporting activities organised by FUFA;
- d) To exercise all other rights arising from the Statutes and regulations of FUFA.

2.

The exercise of these rights is subject to other provisions in these Statutes and the applicable Regulations:

13 Members' obligations

1.

The Members of FUFA have the following obligations:

- a) To comply fully with the Statutes, Regulations, Directives and Decisions of FIFA, CAF and FUFA at all times and to ensure that these are also respected by its members;
- b) To ensure the election of its decision-making bodies;
- c) To take part in competitions [if applicable] and other sports activities organised by FUFA;
- d) To pay their membership subscriptions;
- e) To respect the Laws of the Game as laid down by IFAB and the Beach Soccer Laws of the Game and the Futsal Laws of the Game as laid down by FIFA, and to ensure that these are also respected by its members through a statutory provision;
- f) To adopt a statutory clause specifying that any dispute requiring arbitration involving itself or one of its members and relating to the Statutes, Regulations, Directives and Decisions of FIFA, CAF, FUFA or the League(s) shall only be referred to the arbitration mechanism provided for in the National Sports Act, Cap 151 or to the Court of Arbitration for Sports (CAS) in Lausanne, Switzerland, both as specified in the FIFA Statutes and in these Statutes, and that any recourse to Ordinary Courts is prohibited, provided that this does not violate binding law.
- g) To communicate to FUFA any amendment of its statutes and regulations as well as the list of its Officials or persons who are authorised signatories with the right to enter into legally binding agreements with third parties;
- h) Not to maintain any relations of a sporting nature with entities that are not recognised or with Members and persons that have been suspended or expelled;
- i) To observe the principles of loyalty, integrity and good sporting behaviour as an expression of fair play through a statutory provision;
- j) To observe the mandatory items specified under article 10 paragraph 11 for the duration of their affiliation;
- k) To administer a register of members which shall regularly be updated;
- l) To ratify statutes that are in accordance with the requirements of the Statutes of FUFA;
- m) To comply fully with all other duties arising from the Statutes and other regulations of FIFA, CAF and FUFA.
- n) To manage their affairs independently and ensure that their own affairs are not influenced by third parties;

2.

Violation of the above-mentioned obligations by any Member may lead to sanctions provided for in these Statutes.

3.

Violations of Article 13.1 (n) may also lead to sanctions even if the third-party influence was not the fault of the Members concerned.

14 Members' Statutes.

1.

Members' statutes must comply with the principles of good governance, and shall in particular contain, at a minimum, provisions relating to the following matters:

- a) to be neutral in matters of politics and religion;
- b) to prohibit all forms of discrimination;
- c) to be independent and avoid any form of political interference;
- d) to ensure that judicial bodies are independent (separation of powers);
- e) all relevant stakeholders must agree to respect the Laws of the Game, the principles of loyalty, integrity, sportsmanship and fair play as well as the Statutes, regulations and decisions of FIFA, CAF and FUFA
- f) all relevant stakeholders must agree to recognize the jurisdiction of the arbitration mechanism provided for in the National Sports Act, Cap 151, if not operationalized in accordance with the law, the authority of CAS shall be given priority as a means of dispute resolution;
- g) definition of the competences of the decision-making bodies;
- h) to avoid conflicts of interest in decision-making;
- i) legislative bodies must be constituted in accordance with the principles of representative democracy and taking into account the importance of gender equality in football.

15 Suspension

1.

The General Assembly is responsible for suspending a Member Association or Entity. Notwithstanding the foregoing, the FUFA Executive Committee may, temporarily suspend with immediate effect a Member Association or entity that seriously and/or repeatedly violates its obligations as a member. A suspension approved by the FUFA Executive Committee shall be in effect until the next General Assembly, unless the FUFA Executive Committee has revoked such suspension prior to such General Assembly.

2.

A suspension shall be confirmed at the next General Assembly by a three-quarter majority of the delegates representing the Members present and eligible to vote. If it is not confirmed, the suspension is automatically lifted.

3.

A suspended Member shall lose its membership rights. Other Members may not entertain sporting contact with a suspended Member. The Ethics and Disciplinary Committee may impose further sanctions.

MEMBERSHIP

4.

Members or entities that do not participate in the sports activities of FUFA for two consecutive years shall be suspended from voting at the General Assembly and their representatives shall not be elected or appointed until they have fulfilled their obligations in this respect.

16 Expulsion

1.

The General Assembly may expel a Member Association or Club if:

- a) It fails to fulfil its financial obligations towards FUFA;
- b) It repeatedly violates the Statutes, Regulations, Directives or Decisions of FIFA, CAF and FUFA;
- c) It brings a dispute to an Ordinary Court, except in cases where the FIFA, CAF or FUFA regulations or binding legal provisions specifically provide for or stipulate recourse to Ordinary Courts.

2.

The presence of a majority (more than 50%) of Members entitled to vote at the General Assembly is necessary for an expulsion to be valid, and the motion for expulsion must be adopted by a three-quarter majority of the valid votes cast.

17 Resignation

1.

A Member may resign from FUFA with effect from the end of a football season. Notice of resignation must reach the general secretariat no later than six months before the end of the calendar year.

2.

The resignation is not valid until the Member wishing to resign has fulfilled its financial obligations towards FUFA and the other Members of FUFA.

18 Independence of Members and their bodies

1.

Each Member shall manage its affairs independently and with no influence from third parties.

2.

A Member's bodies shall be either elected or appointed in accordance with these Statutes and/or the member's Statutes.

3.

A Member's Statutes shall provide for a procedure that guarantees the complete independence of the election or appointment.

4. Any Member's bodies that have not been elected or appointed in compliance with the provisions of Article 18 (2) & (3) even on an interim basis shall not be recognised by FUFA.
5. Decisions passed by bodies that have not been elected or appointed in compliance with Article 18(2) & (3) shall not be recognised by FUFA.

19 Status of Members, Clubs, Leagues, Regional Associations and other groups of Clubs

1. Clubs, Leagues, Regional Associations or any other groups of Clubs affiliated to FUFA shall be subordinate to and recognised by FUFA. These Statutes define the scope of authority and the rights and duties of these Clubs and groups. Their Statutes and Regulations must be approved by the Executive Committee of FUFA. There shall only be one top-tier national league on the territory of Uganda.
2. The Members of FUFA shall take all decisions on any matters regarding their membership independently of any external body. This obligation applies regardless of their corporate structure.
3. In any case, no natural or legal person (including holding companies and subsidiaries) shall exercise control over more than one Club or group whenever the integrity of any match or competition could be jeopardised.
4. Members shall be subordinate to FUFA and shall comply with these Statutes, the Regulations, and any Directive issued by FUFA.
5. Any amendments to the statutes, rules, or regulations of a member shall only become effective upon ratification by the FUFA Executive Committee.
6. No provision of the Statutes or rules or regulations of a member or any amendment thereof which conflicts with a provision of these Statutes, the statutes of CAF or FIFA shall be of any force and effect until ratified by the FUFA emergency Committee or FUFA Executive Committee as the case may be.
7. Article 82 of these statutes stipulates the responsibilities withheld by FUFA in event of delegation of authority to organise a FUFA Competition

HONORARY PRESIDENT AND HONORARY MEMBER.

III. HONORARY PRESIDENT AND HONORARY MEMBER.

20 Honorary president and honorary member

1.

The General Assembly may bestow the title of honorary president or honorary member upon any persons for meritorious service to football.

2.

The Executive Committee shall make these nominations.

3.

The honorary president or honorary member may take part in the General Assembly. They may join the debates but are not entitled to vote.

IV. ORGANISATION

21 Bodies of FUFA

1.

The bodies of FUFA Include;

- a) **The General Assembly** is the supreme and legislative body.
- b) **The Executive Committee** is the executive body.
- c) **The Emergency Committee** as defined in these Statutes.
- d) **Standing and ad-hoc committees** shall advise and assist the Executive Committee in fulfilling its duties. Their duties, composition and function are defined in these Statutes and/or special regulations drawn up by the Executive Committee.
- e) **The general secretariat** is the administrative body that implements the decisions of the other bodies herein that are mandated by these statutes to take decisions.
- f) **The FUFA Judicial Commission** is the body that shall interpret and administer justice of the FUFA Statutes and Regulations
- g) **The Licensing Body** is the body in charge of the licensing system within FUFA.
- h) **The FUFA Electoral Committee** is the body in charge of organising and supervising the election process.

2.

The bodies of FUFA shall be elected, appointed or established by FUFA itself without any external influence and in accordance with the procedures described in these Statutes.

3.

Any member of the bodies of FUFA shall withdraw from the debates and from taking a decision if there is any risk or possibility of a conflict of interest.

4.

The members of the bodies of FUFA shall not have previously been found guilty of any criminal offence incompatible with their position.

IV. ORGANISATION

A. GENERAL ASSEMBLY

22 Definition and composition of the General Assembly

1.

The General Assembly is the meeting at which all of the Members of FUFA regularly convene. It represents the supreme and legislative authority of FUFA. Only a General Assembly that is duly convened has the authority to make decisions.

2.

A General Assembly may be Ordinary or Extraordinary.

3.

The President shall conduct the General Assembly business in compliance with the standing orders of the General Assembly.

4.

The General Assembly may appoint observers who take part in the General Assembly without the right to debate or to vote.

23 Delegates and votes

1.

The General Assembly is composed of 88 delegates. The number of delegates is allocated as follows:

2.

Each of the eight (8) Regional Football Associations will be represented by six (6) delegates. Of the six (6) Delegates from each of the Regional Football Associations, there shall be at least one (1) delegate from the constituent Province Football Associations.

3.

The delegates from the FUFA Special Interest Groups shall be as follows;

IV. ORGANISATION

- 4.**
At least One (1) of the six (6) delegates from each of the Regional Football Associations shall be a woman.
- 5.**
One (1) of the six (6) delegates from each of the Regional Football Associations shall be elected by and shall represent the 3rd Division League Clubs.
- 6.**
At least One (1) of the three (3) delegates from the Uganda Football Referees Association shall be a Woman.
- 7.**
Delegates must belong to the Member that they represent and be appointed or elected by the appropriate body of that Member. They must also be able to produce evidence of this upon request.
- 8.**
Only the Chairperson, or if unavailable, the Vice Chairperson, or if both are absent, the Club CEO, may represent a FUFA 1st Division League Club as a Delegate at the FUFA General Assembly. "For avoidance of doubt, the Chairperson shall mean the highest decision-making person of the body elected/appointed by the club owner.
- 9.**
The Delegates to the General Assembly representing the FUFA Women Elite League, 2nd and 3rd FUFA Division Leagues shall ONLY continue to represent their respective Leagues to the FUFA General Assembly for the period their respective clubs are playing in the respective League.
- 10.**
There will be an annual election for positions of the delegates that become vacant by provisions of these statutes. These elections will always take place before the 31st of August.
- 11.**
Each delegate of the same category of Member has an equal number of votes in the General Assembly. Only the delegates present are entitled to vote. Voting by proxy or by letter is not permitted.
- 12.**
The Executive Committee and the Chief Executive Officer shall take part in the General Assembly without voting rights. During their terms of office, members of the Executive Committee of FUFA shall not represent their respective FUFA Members as delegates to the FUFA General Assembly.
- 13.**
Subject to Article 23(12) the delegates to the FUFA General Assembly who are still serving members of the FUFA Executive Committee shall have a right to vote for the election of the FUFA Executive Committee.
- 14.**

IV. ORGANISATION

The President shall conduct the General Assembly business in compliance with the Standing Orders of the FUFA General Assembly.

24 Areas of authority

1.

The General Assembly has the following authority:

- a) Adopting or amending the Statutes, Regulations governing the application of the Statutes, the standing orders of the General Assembly and the electoral code;
- b) Appointing 3 Members to check the minutes and approving the minutes of the last meeting;
- c) Electing the President and the vice-presidents and members of the Executive Committee;
- d) Electing or dismissing the Chairperson, deputy Chairperson and members of the judicial bodies;
- e) Appointing the scrutineers;
- f) Approving the financial statements of the previous year;
- g) Approving the budget forecast for the next financial year;
- h) Approving the activity report;
- i) Appointing the independent auditors upon the proposal of the Executive Committee;
- j) Appointing the independent auditors of the different Legal Entities owned by FUFA that are created under these statutes upon the proposal of the Executive Committee.
- k) Determining and passing of the annual membership subscriptions fees on the recommendation of the Executive Committee;
- l) Deciding, upon the nomination of the Executive Committee, whether to bestow the title of honorary president or honorary member;
- m) Admitting, suspending or expelling a member;
- n) Establishing legal entities, owned by FUFA and/or its members, for purposes of commercialization of FUFA Commercial Properties with the aim of generating revenue for the utilization of FUFA and its members in order to achieve their objectives;
- o) Revoking the mandate of one or a number of members of a body of FUFA;
- p) Dissolving FUFA;
- q) Passing decisions at the request of a member in accordance with these Statutes;
- r) Electing or dismissing the members of the FUFA Electoral Committee;
- s) Electing or dismissing the members of the Audit and Compliance Committee.

25 Quorum of the General Assembly

1.

Decisions passed by the General Assembly shall only be valid if the majority (more than 50%) of delegates representing the Members eligible to vote are present.

2.

If a quorum is not achieved, a second General Assembly shall take place within 24 hours, with the same agenda.

3.

A quorum is not required for the second meeting of the General Assembly with the same agenda but excluding agenda items of amendment of the Statutes of FUFA, the election of the President and election of the vice-presidents and members of the Executive Committee, the dismissal of one or a number of members of a body of FUFA, the expulsion of a Member of FUFA or the dissolution of FUFA.

26 Decisions of the General Assembly

1.

Unless otherwise stipulated in the Statutes, a majority (more than 50%) of the valid votes cast is sufficient for a decision to be valid. Blank ballot papers, invalid votes or electronic votes manipulated in any other way as well as abstentions shall be disregarded when calculating the majority.

2.

A decision that requires a vote shall be reached by a show of hands or by means of an electronic count. If a show of hands does not result in a clear majority in favour of a motion, the vote shall be taken by calling the roll in alphabetical order.

27 Elections

1.

The Election of the FUFA President and the Executive Committee Shall be by List.

2.

The List which receives the most votes shall be the one considered elected. In event of only one candidature list, the Executive Committee shall have been elected by acclamation of the General Assembly convened for the purpose.

3.

Elections shall be conducted by secret ballot.

4.

Elections at FUFA, Members of FUFA and Members of Members of FUFA shall be conducted in accordance with the FUFA Electoral Code.

5.

For the election of the chairmen, deputy chairmen and members of all other bodies of FUFA [e.g., Audit and Compliance Committee, judicial bodies], the Executive Committee will propose the candidates and the General Assembly will elect.

6.

In case of a tied vote, new ballots shall be conducted until the respective candidate or list is elected in accordance with the procedure set forth by the present provision.

28 Ordinary General Assembly.

1.

The Ordinary General Assembly shall, as a rule, be held yearly by the 31st October at the latest.

IV. ORGANISATION

2.

The Executive Committee shall fix the place and date. The Members shall be notified in writing as well as by publication in a national newspaper at least three months in advance. In times of force majeure or in case the members of the Assembly are prevented from meeting in person, the Executive Committee is authorised to organise a Virtual Assembly.

3.

The formal convocation shall be made in writing at least one month before the date of the General Assembly. This convocation shall contain the agenda, the activity report, the financial statements and the auditors' report and any other relevant documents.

29 Ordinary General Assembly agenda.

1.

The Chief Executive Officer shall draw up the agenda based on proposals from the Executive Committee and the Members. Any proposal that a Member wishes to submit to the General Assembly shall be sent to the general secretariat in writing, with a brief explanation, at least two months before the date of the General Assembly.

2.

The General Assembly agenda shall include the following mandatory items:

- a) a declaration that the General Assembly has been convened and composed in compliance with the Statutes of FUFA;
- b) Approval of the agenda;
- c) Appointment of Members to check the minutes;
- d) Appointment of Scrutineers;
- e) An address by the President;
- f) Suspension or expulsion of Members (if applicable);
- g) Admission of Membership (if applicable);
- h) Approval of the minutes of the preceding General Assembly;
- i) Activity report (containing the activities since the last General Assembly);
- j) Presentation of the consolidated and revised balance sheet and the profit and loss statement of FUFA;
- k) Approval of the financial statements of FUFA;
- l) Approval of the budget of FUFA;
- m) Appointment of independent auditors (if applicable) upon the proposal of the Executive Committee;
- n) Reports, Discussions and Decisions of the AGM of the different Legal Entities owned by FUFA and established in accordance with these Statutes. These Include:
 - i. Annual reports
 - ii. Presentation and approval of the financial reports
 - iii. Appointment of Independent Auditors upon proposal of the Boards of Directors of the respective Legal Entities owned by FUFA
- o) Votes on proposals for amendments to the Statutes, the Regulations governing the application of the Statutes, the standing orders of the General Assembly and the FUFA Electoral Code (if applicable);

IV. ORGANISATION

- p) Discussion of proposals submitted by the Members and the Executive Committee;
- q) Dismissal of a person or a body (if applicable);
- r) Election of the President, vice-presidents and members of the Executive Committee (if applicable);
- s) Election of the Members of the independent committees (if applicable)
 - i. FUFA Judicial Commission
 - ii. Audit and Compliance Committee
 - iii. Electoral Committee
- t) Any further items proposed by the Members or the Executive Committee of FUFA, in compliance with paragraph 1 and 3 of this provision.

3.

The agenda of an Ordinary General Assembly may be altered, provided three-quarters of the Members present at the General Assembly and eligible to vote agree to such a motion.

4.

The General Assembly shall not make a decision on any point not included in the agenda.

30 Extraordinary General Assembly

1.

The Executive Committee may convene an Extraordinary General Assembly at any time.

2.

The Executive Committee shall convene an Extraordinary General Assembly if 50% of the delegates representing the Members of FUFA make such a request in writing. The request shall specify the items for the agenda. An Extraordinary General Assembly shall be held within one month of receipt of the request. If an Extraordinary General Assembly is not convened, the delegates representing the Members who requested it may convene the General Assembly themselves. As a last resort, the delegates representing the Members may request assistance from FIFA and CAF.

3.

The Members shall be notified of the place, date and agenda at least two weeks before the date of an Extraordinary General Assembly.

4.

When an Extraordinary General Assembly is convened on the initiative of the Executive Committee, it must draw up the agenda. When an Extraordinary General Assembly is convened upon the request of Members, the agenda must contain the points raised by those Members.

5.

The agenda of an Extraordinary General Assembly shall not be altered.

IV. ORGANISATION

31 Amendments to the Statutes, Regulations governing the application of the Statutes, the standing orders of the General Assembly and the FUFA Electoral Code

1.

The General Assembly is responsible for amending the Statutes, the Regulations governing the application of the Statutes, the standing orders of the General Assembly and FUFA Electoral Code.

2.

Any proposals for an amendment to the Statutes and the FUFA Electoral Code must be submitted in writing with a brief explanation to the general secretariat by a member or by the Executive Committee. A proposal submitted by delegates representing a member is valid, provided it has been supported in writing by at least 40% of the delegates representing the Members.

3.

For a vote on an amendment to the Statutes and the FUFA Electoral Code to be valid, a majority (more than 50%) of the delegates representing Members eligible to vote must be present.

4.

A proposal for an amendment to the Statutes and the FUFA Electoral Code shall be adopted only if three-quarters of the delegates representing the Members present and eligible to vote agree to it.

5.

Any proposal to amend the Regulations governing the application of the Statutes, and the standing orders of the General Assembly must be submitted in writing with a brief explanation to the general secretariat by the delegates representing a member or by the Executive Committee.

6.

A proposal for an amendment to the Regulations governing the application of the Statutes, the standing orders of the General Assembly shall be adopted only if a majority (more than 50%) of the valid votes cast.

32 Minutes

1.

The Chief Executive Officer shall be responsible for recording the minutes at the General Assembly.

2.

The minutes shall be checked by those Members designated and finally approved at the next General Assembly.

33 Effective dates of decisions

1.

Decisions passed by the General Assembly shall come into effect for the Members 60 days after the close of the General Assembly, unless otherwise stipulated in the present Statutes or unless the General Assembly fixes another date for a decision to take effect.

B. EXECUTIVE COMMITTEE

34 Composition

1.

The Executive Committee consists of 17 persons:

- a) The President
- b) 1st Vice-President
- c) 2nd Vice-President
- d) 3rd Vice-President, from the Professional Leagues
- e) 13 persons, with at least one representative from each of the FUFA Regional Football Associations.

2.

Of the 17 Members of the Executive Committee, at least 3 shall be female persons. Such female member positions shall not prevent any woman from being appointed or elected to other positions within the FUFA Executive Committee.

3.

The President, the 1st Vice-President, the 2nd Vice-President and the members of the Executive Committee shall be elected by list system. The 3rd Vice-President shall be nominated through an election by the 1st and 2nd Division Men League Clubs and ratified by FUFA General Assembly for a mandate of four years provided the club he/she represents continues to play in the 1st and 2nd Division Leagues. Only a 1st Division Club may nominate a candidate for the position of a 3rd Vice President but each of the 1st and 2nd Division Club shall have one vote in case of an election.

4.

The mandate of the President, vice-presidents and members of the Executive Committee is for four years starting on 31st August of their year of election. They may be re-elected.

5.

In event that the election of the FUFA Executive Committee by the end of the mandate cannot take place because of reasons of force majeure or any other circumstances beyond the control of the FUFA Executive Committee, the FUFA Executive Committee shall continue to exercise its powers as provided for in these statutes inclusive of completing the election process but in any case, not later than six (6) months from the end of the said term.

IV. ORGANISATION

6.

The FUFA Chief Executive Officer will organise the Handover Ceremony for the elected executive Committee of FUFA.

7.

The members of the Executive Committee shall be no older than 70 years and no younger than 25 years at the moment of the election. They shall have had football administrative experience as defined in the FUFA electoral code, must have been resident within the territory of Uganda for two years prior to the elections, be a citizen of Uganda, hold a minimum of Uganda Certificate of Education or an equivalent determined by the National Council for Higher Education, must not be serving a ban entered in force, must not have been previously found guilty of a felony offence and must not have been declared bankrupt.

8.

Candidatures must be sent to the general secretariat of FUFA. The official list of candidates must be passed to the Members of FUFA along with the agenda for the General Assembly at which the Executive Committee will be elected.

9.

A member of the Executive Committee may not at the same time be a member of a judicial body of FUFA.

10.

If a position or less than 50% of the positions of the Executive Committee become vacant, the Executive Committee shall fill that position until the next General Assembly, when a replacement will be elected for the remaining term of the mandate.

11.

If more than 50% of the positions of the Executive Committee become vacant, the Electoral Committee shall convene an Extraordinary General Assembly within two months in order to elect the replacements for the remaining term of mandate. If an Electoral Committee does not exist, the Emergency Committee shall convene the Extraordinary General Assembly. In case the Emergency Committee lacks the required quorum, the Chief Executive Officer shall convene the Extraordinary General Assembly within the prescribed period of time.

12.

A position shall be considered to be vacant in case of death, resignation, severe permanent disability, or permanently prevented from performing his/her official function, suspension or ban by FUFA Judicial bodies for a period of more than one (1) year.

35 Meetings

1.

The Executive Committee shall meet at least once every quarter a year.

2.

The President shall convene the Executive Committee meetings. If 50% of the Executive Committee members request a meeting, the President shall convene it within 21 days. In case

the President fails to convene the meeting, the requesting Executive Committee Members may convene it themselves.

3.

The Chief Executive Officer (CEO) shall compile and the President shall approve the agenda. Each member of the Executive Committee is entitled to propose items for inclusion in the agenda. The members of the Executive Committee must submit the points they wish to be included in the agenda for the meeting to the general secretariat at least 14 days before the meeting. The agenda must be sent out to the members of the Executive Committee at least 7 days before the meeting.

4.

The CEO shall take part in the meetings of the Executive Committee in a consultative role.

5.

The meetings of the Executive Committee shall not be held in public. The Executive Committee may, however, invite third parties to attend. Those third parties shall not have voting rights, and may only express an opinion with the permission of the Executive Committee.

36 Powers of the Executive Committee.

1.

The Executive Committee:

- a) Shall take decisions not reserved for any other body of FUFA by law or under these Statutes
- b) Shall prepare and convene the Ordinary and Extraordinary General Assembly of FUFA
- c) Shall appoint the chairmen, deputy chairmen and members of the standing committees except the audit and Compliance Committee
- d) May decide to set up ad-hoc committees, if necessary, at any time;
- e) Shall compile the Regulations for the organisation of standing committees and ad-hoc committees;
- f) Shall appoint or dismiss the Chief Executive Officer on the proposal of the President.
- g) Shall propose the independent auditors to the General Assembly;
- h) Shall appoint replacements for vacancies in the judicial bodies or the Audit and Compliance Committee until the next General Assembly;
- i) Shall draw up Regulations governing the conditions of participation in and the staging of competitions organised by the Association;
- j) Shall appoint the coaches for the representative teams and other technical staff;
- k) Shall approve Regulations stipulating how FUFA shall be organised internally;
- l) Shall ensure that the Statutes are applied and adopt the executive arrangements required for their application;
- m) May suspend or dismiss a person or body until the next General Assembly;
- n) May suspend a Member of FUFA provisionally until the next General Assembly
- o) May delegate tasks arising out of its area of authority to other bodies of FUFA or third parties.
- p) May commit FUFA to borrow.
- q) Shall implement the decisions of the General Assembly through the FUFA Secretariat.
- r) Shall maintain and update the list of Members of FUFA;

IV. ORGANISATION

37 Decisions

1.
The Executive Committee shall not engage in valid debate unless the majority (more than 50%) of its members are present.
2.
The Executive Committee shall reach decisions by a majority (more than 50%) of the valid votes cast. In the event of a tied vote, the President shall have the casting vote. Voting by proxy or by letter is not permitted.
3.
Any member of the Executive Committee must withdraw from the debate and from taking a decision if there is any risk or possibility of a conflict of interest.
4.
The decisions taken shall be recorded in the minutes.
5.
The decisions taken by the Executive Committee shall come into effect immediately, unless the Executive Committee decides otherwise.

38 Dismissal of a person or body

1.
The General Assembly may dismiss a person or body. The Executive Committee may place the dismissal of a person or body on the agenda for the General Assembly. The Executive Committee may also dismiss a person or body provisionally. Any Executive Committee member may submit a proposal to place such a motion for dismissal on the agenda of the Executive Committee or General Assembly.
2.
The motion for dismissal must be justified. It will be sent to the members of the Executive Committee and/or to the Members of FUFA along with the agenda.
3.
The person or body in question has the right to speak in his/her or its own defence.
4.
The motion for dismissal shall be decided by means of secret ballot. For the motion to be passed, a majority of two-thirds of the valid votes is required.
5.
The person or body dismissed (provisionally) is relieved of his/her or its functions with immediate effect.

C. PRESIDENT

39 President

1.
The President represents FUFA Generally and legally.
2.
He is primarily responsible for:
 - a) Implementing the decisions passed by the General Assembly and the Executive Committee through the general secretariat;
 - b) Ensuring the effective functioning of the bodies of FUFA in order that they achieve the objectives described in these Statutes;
 - c) Supervising the work of the general secretariat;
 - d) Relations between FUFA and its Members, FIFA, CAF, political bodies and other organisations.
3.
Only the President may propose the appointment or dismissal of the Chief Executive Officer.
4.
The President shall preside over the General Assembly, the Executive Committee and Emergency Committee meetings and those committees of which he has been appointed Chairperson.
5.
The FUFA President shall be the Chairperson of the Board of Directors of each Legal Person incorporated.
6.
The President shall have an ordinary vote on the Executive Committee and, whenever votes are equal, shall have a casting vote.
7.
The position of the President will be considered vacant if he does not participate in three (3) consecutive meetings of the Executive Committee without an appropriate excuse.
8.
If the President is absent or unavailable, the 1st Vice-President shall act as the President and if both the President and 1st Vice-President are absent, the 2nd Vice President shall act as the President and if the President, 1st Vice-President and 2nd Vice President are absent, the 3rd Vice President shall act as the President until the next General Assembly. Such General Assembly shall elect a new President for the remaining period of office.
9.
Any additional powers of the President shall be contained in the internal organisation regulations of FUFA.

IV. ORGANISATION

40 Candidates for the office of the President

1.
The President shall be no older than 70 years and no younger than 30 years at the moment of the election. They shall have had football administrative experience as defined in the FUFA electoral code, must have been resident within the territory of Uganda for two years prior to the elections, be a citizen of Uganda, hold a minimum of Uganda Advanced Certificate of Education or an equivalent determined by the National Council for Higher Education, must not be serving a ban entered in force, must not have been previously found guilty of a felony offence and must not have been declared bankrupt.
2.
Only Members of FUFA may propose candidates for the office of President. Members shall notify the general secretariat in writing of the name of a candidate for the presidency of FUFA at least two months before the date of the General Assembly.
3.
The general secretariat shall notify the Members of the names of the proposed candidates at least 1(one) month before the date of the General Assembly.
4.
If the President is prevented from performing his/her official function for a year, the 1st Vice-President shall assume the presidency until the end of the term.

41 Representation and signature

1.
The President represents FUFA Generally and is entitled to sign for FUFA. The Executive Committee may set up internal organisation Regulations regarding the joint signature of officers, in particular, in case of the President's absence and concerning all important business of FUFA.

D. EMERGENCY COMMITTEE

42 Emergency Committee

1.
The Emergency Committee shall deal with all matters requiring immediate settlement between two meetings of the Executive Committee. The Committee shall consist of the President, the three Vice-Presidents and 1(one) member chosen from amongst the members of the Executive Committee and appointed by the Executive Committee for a period of 4 years.
2.
The President shall convene the Emergency Committee meetings. If a meeting cannot be convened within an appropriate period of time, decisions may be passed through other means

IV. ORGANISATION

of communication. Such decisions shall have immediate legal effect. The President shall notify the Executive Committee immediately of the decisions passed by the Emergency Committee.

3.

The Emergency Committee shall not engage in valid debate unless three (3) of its members take part in the debate. The Emergency Committee shall reach decisions by a majority (more than 50%) of the valid votes cast. In the event of a tied vote, the President shall have the casting vote.

4.

All decisions taken by the Emergency Committee shall be ratified by the Executive Committee at its next meeting.

5.

If the President is unable to attend a meeting, the 1st Vice-President available shall deputise. A decision from the Emergency Committee shall be deemed valid if three members voted it.

6.

The President is entitled to designate another Member of the Executive Committee for any member who is unable to attend or has a conflict of interest. The President may also invite a member of the Executive Committee who is concerned with the matter under the consideration of the Emergency Committee in the event he has no conflict of interest in the matter.

E. FUFA COMMITTEES

43 Types of Committees

1.

FUFA Committees will be composed of

- a) Standing Committees
- b) Ad hoc and Expert committees

2.

Standing Committees are appointed by and report to the FUFA Executive Committee, while ad hoc committees may be established by the Executive Committee for specific tasks and durations.

3.

The standing committees of FUFA are:

4. Governance

- a) Administration Committee
- b) Stakeholders Committee
- c) Legal & Rules Committee
- d) FUFA Licensing Committee

5. Sport

- a) Competitions Committee
- b) Football Development Committee
- c) Women Football Committee
- d) FUFA Technical Committee

IV. ORGANISATION

- e) Medical & Anti-Doping Committee
- f) FUFA Referees' Standing Committee
- g) Security and Safety Committee

6. Business

- a) Media and Communications Committee
- b) Marketing Committee
- c) Finance Committee
- d) International Match Organising Committee

7. Infrastructure & Projects

- a) Infrastructure & Projects Committee

8.

The chairmen of the standing committees shall be members of the Executive Committee. The Executive Committee may take decisions on which specialised committees may be chaired by Persons that are not members of the Executive Committee

9.

The members of each standing committee shall be appointed by the Executive Committee on the proposal of the Members of FUFA or the President of FUFA. The chairmen, deputy chairmen and the members of the standing committees shall be designated for a term of office of two (2) years. Members may be re-appointed and may also be relieved of their duties at any time by the executive committee.

10.

Each Chairperson shall represent his/her committee and conduct business in compliance with the relevant organisation Regulations drawn up by the Executive Committee.

11.

Each Chairperson shall fix the dates of meetings in collaboration with the Chief Executive Officer, ensure that all tasks are carried out and report back to the Executive Committee.

12.

Each committee may propose amendments to its Regulations to the Executive Committee.

44 Administration Committee

The administration committee shall regularly evaluate the effectiveness of FUFA's governance, staff performance, human resource manual, risk management and control processes based on FUFA's strategic plan. It shall consist of a Chairperson, a deputy Chairperson and 3 members who shall be qualified to handle administration matters.

45 Football Stakeholders Committee

The Football Stakeholders Committee shall deal with matters of both internal and external stakeholders, particularly the relationship between clubs, players, leagues, member associations, as well as relationship with external stakeholders including government, sponsors, fans among others. It shall consist of a Chairperson, a deputy Chairperson and 3 members.

46 Legal & Rules Committee

The Legal Committee is responsible for advising on and assisting with football-related legal matters and FUFA's legal obligations. It shall provide legal advice to the Executive Committee regarding the FUFA Statutes, as well as all rules and regulations of FUFA, and offers guidance on any disputes involving FUFA. The committee shall comprise a Chairperson, a Deputy Chairperson, and 3 members.

47 FUFA Licensing Committee

The FUFA Licensing Committee shall deal with matters of examining, verifying and advising the Executive committee about the compliance and capability of FUFA licensees including but not limited to clubs, football competitions, player agents, match agents and academies. It shall consist of a Chairperson, a deputy Chairperson and 3 members.

48 Competitions Committee

The Competitions Committee shall organise the official competitions of FUFA and any other competitions assigned by FUFA in compliance with the provisions of these Statutes and the Regulations applicable to FUFA competitions. The Competitions Committee may recommend to the FUFA Executive Committee to delegate its full or some of the specific competition organising responsibilities to another body. It shall consist of a Chairperson, a deputy Chairperson and 3 members.

49 FUFA Referees' Standing Committee

The Referees' Committee shall implement the Laws of the Game. It shall appoint the referees for matches in competitions organised by FUFA, organise refereeing matters within FUFA in collaboration with the administration of FUFA and monitor the education and training of referees. It shall consist of a Chairperson, a deputy Chairperson and 3 members.

IV. ORGANISATION

50 Football Development Committee

The Football Development Committee shall undertake matters of policy and strategy and thereafter advise the FUFA Executive Committee for decision making for Youth Football, Sports Medicine, Beach Soccer, FUTSAL and Education of the Football Human Resource. It shall consist of a Chairperson, a deputy Chairperson and 5 members.

51 Women's Football Committee

The Women's Football Committee shall analyse the basic development aspects and propose to the Executive Committee on the Women football development Programmes and deal with all matters relating to women's football. It shall consist of a Chairperson, a deputy Chairperson and 3 members.

52 FUFA Technical Committee

The FUFA Technical Committee shall supervise and advise the Executive Committee on matters of technical strategy, plans and programmes of the National Teams. The committee shall assess and also oversee the inspection of the technical works of the National Teams and Professional Clubs Coaches. The committee will also oversee the logistics and welfare of the National Teams It shall consist of a Chairperson, a deputy Chairperson and 3 members.

53 Medical & Anti-Doping Committee

The Medical Committee shall advise on and assist with all matters relating to sports medicine and antidoping. The committee shall also propose regulations regarding medical services at matches and tournaments, preventing injury and improving treatment and medical guidelines for coaches, players, referees and assistant referees. The committee will also oversee the medical logistics and welfare of the National Teams It shall consist of a Chairperson, a deputy Chairperson and 3 members.

54 Safety and Security Committee

The Security and Safety Committee shall deal with matters of safety and security of the persons and property at FUFA premises, FUFA authorised or organised football venues and events. It shall work in tandem with the national security organs. It shall consist of a Chairperson, a deputy Chairperson and 3 members.

55 Media and Communications Committee

The Media and Communications shall advise on and assist in defining and supervising the implementation of the media and communications strategy of FUFA, FUFA publications and Public Relations. The committee shall also oversee the policy for media activities and accreditation at FIFA tournaments and events and advise on and assist with any other relevant media and communication matters. It shall consist of a Chairperson, a deputy Chairperson and 3 members.

56 Marketing Committee

The Marketing Committee shall advise on and assist in defining and supervising the implementation of the commercial and marketing strategy of FUFA, make recommendations on increasing commercial revenue streams for FUFA and the member associations and also make recommendations in improving the brands and brand value of the commercial assets of FUFA and its Members. The committee shall also advise on and assist with any other relevant commercial and marketing related matters. It shall consist of a Chairperson, a deputy Chairperson and 3 members.

57 Finance Committee

The Finance Committee shall monitor the financial management and advise the Executive Committee on financial matters and asset management. It shall analyse the budget of FUFA and the financial statements prepared by the Chief Executive Officer and submit them to the Executive Committee for approval. It shall consist of a Chairperson, a deputy Chairperson and 3 members.

58 International Match Organising Committee

The International Match Organising Committee shall be responsible for managing the event of International Representative Clubs and National Teams international football matches. It shall consist of a Chairperson, a deputy Chairperson and 3 members.

59 Infrastructure & Projects Committee

The Infrastructure and Projects Committee shall advise on and assist with the implementation of FUFA and its Members' infrastructure and other projects, supervise the implementation of FUFA projects and projects provided to member associations. It shall consist of a Chairperson, a deputy Chairperson and 3 members.

60 Ad-hoc committees

The Executive Committee may, if necessary, create ad-hoc committees for special duties and a limited period of time. The Executive Committee shall appoint a chairperson, a deputy chairperson, and the members. The duties and function are defined in special regulations drawn up by the Executive Committee. An ad-hoc committee shall report directly to the Executive Committee.

F. INDEPENDENT COMMITTEES

61 Independent Committees

1. The Independent Committees will be proposed by the FUFA Executive Committee and voted for by the FUFA General Assembly
2. The independent Committees are:
 - a) Audit and Compliance Committee;
 - b) FUFA Judicial Commission
 - c) Electoral Committee

62 Audit and Compliance Committee

1. The Audit and Compliance Committee shall ensure the completeness and reliability of the financial accounting and review the financial statements, the consolidated financial statement and the external auditors' reports.
2. The Audit and Compliance Committee shall advise and assist the Executive Committee in monitoring the Association's financial and compliance matters, and issue and monitor compliance with the relevant Regulations of FUFA.
3. Details on the Audit and Compliance Committee's responsibilities, its internal cooperation and other procedural matters shall be stipulated in the relevant Regulations of FUFA.
4. The Chairperson and deputy Chairperson of the Audit and Compliance Committee shall be independent, they shall NOT be considered independent if, at any time during the four years preceding their terms, they or any family member (spouse, children, stepchildren, parents, siblings, domestic partner, parents of spouse/domestic partner and siblings and children of a domestic partner):

IV. ORGANISATION

- i. Held any paid position or material contract (directly or indirectly) with FUFA, whereas a voluntary position with an expenses allowance of more than USD 1,000 per month shall also be regarded as a paid position;
- ii. Was employed as FUFA's outside legal counsel or by FUFA's auditor (and was engaged in auditing FUFA);
- iii. Held any paid or voluntary position with a non-profit organisation to which FUFA and/or any Member, CAF, League or Club makes annual payments in excess of USD 25,000.

5.

If the Chairperson, the deputy Chairperson or a member of the Audit and Compliance Committee permanently ceases to perform his/her official function during his/her term of office, the Executive Committee shall appoint a replacement to serve until the next General Assembly.

6.

The Chairperson, deputy Chairperson and members of the Audit and Compliance Committee shall be elected by the General Assembly for a period of two (2) years and may only be relieved of their duties by the General Assembly. They shall undergo an integrity check, to be conducted by the Ethics and Disciplinary Committee, prior to their election or re-election.

63 FUFA Judicial Commission

1.

The FUFA Judicial Commission (FJC) shall be composed of the following categories of bodies.

- a) Office of the Chairperson and Deputy Chairperson FJC
- b) FUFA Disciplinary Panel
- c) FUFA Ethics and Disciplinary Committee composed of Investigatory and Adjudicatory Chamber
- d) FUFA Dispute Resolution Chamber
- e) FUFA Referees Disciplinary Panel
- f) FUFA Appeals Committee

2.

The FUFA Judicial Commission shall be independent in decision making of any other bodies or offices or individual persons.

3.

The judicial bodies shall consist of a Chairperson, a deputy Chairperson and a specific number of other members.

4.

The FUFA Judicial Commission shall be composed in such a way that the members, together, have the knowledge, abilities and specialist experience that is necessary for the due completion of their tasks.

5.

All members of the FUFA Judicial Commission shall undergo an integrity check prior to their election or re-election

IV. ORGANISATION

6.

The Chairperson of the Investigatory Chamber will possess legal and/or investigative training or experience.

7.

The Chairpersons of the Adjudicatory Chamber and the Appeals Committee will possess legal and/or adjudicatory training or experience.

8.

This integrity check shall be conducted by the Audit and Compliance Committee for all members of the FUFA Judicial Commission. The term of office of all members shall be two (2) years. The members may be re-elected or relieved of their duties at any time, although they may only be relieved of their duties by the General Assembly.

9.

The members of the FUFA Judicial Commission shall be elected by the General Assembly upon proposal of the Executive Committee and shall not be members of the Executive Committee or of a standing committee.

10.

The chairperson and deputy Chairperson of the FUFA Judicial Commission shall fulfil the same independence criteria that are stipulated in Article. 62 par. 4 for the Chairperson and deputy Chairperson of the Audit and Compliance Committee.

11.

If the chairperson, deputy chairperson, or a member of the FUFA Judicial body is unable to continue performing their official duties during their term of office, the Executive Committee will appoint a replacement who will serve until the next General Assembly.

12.

The responsibilities and function of the FUFA Judicial Commission shall be stipulated in the respective detailed FUFA Regulations.

64 Functioning of the FUFA Judicial Commission

1.

There shall be the Office of the Chairperson of the FUFA Judicial Commission. The role of the Chairperson of the FUFA Judicial Commission shall be to superintend, administer and enforce fair and fast justice of the entire FUFA Judicial Commission.

2.

There shall also be a Deputy Chairperson of the FUFA Judicial Commission who shall deputise the Chairperson and shall act upon delegation by or in periods of unavailability of the Chairperson.

IV. ORGANISATION

3.

There shall be the FUFA Disciplinary Panel as composite part of the FUFA Judicial Commission. The role of the FDP shall be to primarily interpret and apply FUFA Rules in matters of competitions and those assigned by the Chairperson of the FUFA Judicial Commission that do not require intensive investigations or have no complex factual or legal issues.

4.

There shall be Ethics and Disciplinary Committee-Investigatory Chamber as a composite part of the FUFA Judicial Commission. The role of the Investigatory Chamber shall be to investigate and present final findings to the Adjudicatory Chamber

5.

There shall be Ethics and Disciplinary Committee-Adjudicatory Chamber as composite part of the FUFA Judicial Commission. The role of the Adjudicatory Chamber shall be to take judicial decisions on matters that have complex factual or legal issue and on the findings of the Investigatory Chamber.

6.

There shall be a Referees Disciplinary Panel as composite part of the FUFA Judicial Commission. The role of the Referees Disciplinary Panel shall be to determine and make judicial decision on breaches of referees' Code and corrective measures.

7.

There shall be a Dispute Resolution Chamber as composite part of the FUFA Judicial Commission. The role of the Dispute Resolution Chamber shall be to determine and resolve concerning the status and transfer of players, contractual disputes between clubs, players and coaches.

8.

The functioning of the component bodies of the FUFA Judicial Commission shall be detailed in the FUFA Ethics and Disciplinary Code and relevant FUFA Regulations.

9.

The FUFA Judicial Commission shall be Independent in decision making from any other individuals who are not part of the FUFA Judicial Commission.

65 Appeals Committee

1.

The function of the Appeal Committee shall be governed by the FUFA Ethics and Disciplinary Code and relevant FUFA Regulations. The Appeals Committee shall pass decisions only when at least three members are present. In certain cases, the Chairperson may rule alone in accordance with the FUFA Ethics and Disciplinary Code and relevant FUFA Regulations.

2.

The Appeals Committee is responsible for hearing appeals against decisions of the FUFA Disciplinary Panel and/or the Adjudicatory Chamber that are not declared final by the relevant regulations of FUFA.

67 Settlement of Disputes by Arbitration

1.

FUFA recognises the jurisdiction of arbitrators appointed in accordance with the National Sports Act Cap 151 to resolve disputes between National Council of Sports, FUFA and its Members

2.

The decision of arbitrators appointed under the National Sports Act Cap 151 shall be final

3.

FUFA and its Members are obligated to respect and comply with the decision of the arbitrators appointed in accordance with the National Sports Act Cap 151

4.

Settlement of disputes between FUFA and its Members by courts of Judicature is prohibited. Recourse to ordinary courts of Judicature for all types of provisional/interim measures is also prohibited.

5.

FUFA member associations, Clubs, leagues shall insert a clause in their Statutes or regulations stipulating that it is prohibited to take disputes affecting association football, leagues, members of leagues, clubs, member of clubs, players, officials to ordinary courts of law. The same obligation shall apply to football agents and match agents that are licensed by FIFA.

6.

Any violation of the foregoing provisions will be sanctioned in accordance with the FUFA rules and regulations.

68 Jurisdiction of Arbitrators under National Sports Act Cap 151

1.

Appeals against final decisions rendered by the FUFA Appeals Committee shall be submitted to arbitrators appointed in accordance with the National Sport Act Cap 151.

2.

Recourse shall only be made to arbitration mechanism provided under the National Sports Act Cap 151 after all other internal hearing processes of FUFA have been fully exhausted.

3.

The arbitrators appointed under the National Sports Act Cap 151, shall not have jurisdiction to deal with appeals arising from:

a) violations of the Laws of the Game;

b) Suspensions of up to four matches, or three months, or fines up to UGX one million (excluding doping cases); or any lesser sanction as prescribed in Art 68(3)(b).

IV. ORGANISATION

4.

The appeal to the arbitrators established by the National Sports Act Cap 151, shall not have a suspensive effect.

5.

Any violation of the foregoing provisions will be sanctioned in accordance with the FUFA rules and regulations.

69 Arbitration for international decisions

In accordance with the relevant provisions of the FIFA Statutes, any appeal against a final and binding FIFA decision shall be heard by the Court of Arbitration for Sport (CAS) in Lausanne, Switzerland, CAS shall not, however, hear appeals on violations of the Laws of the Game, and suspensions of up to four matches or up to three months (with the exception of doping decision).

70 Electoral Committee

1.

There shall be an Electoral Committee to organise Elections to Bodies of FUFA whose membership is by election. The committee shall also organise elections of the members and League entities of FUFA;

2.

The Committee shall be nominated, in accordance with the provisions of this code, by the FUFA Executive Committee for a term of four years and approved by the last ordinary general assembly before the elective general assembly of the executive committee.

3.

The FUFA Executive Committee shall also elect three substitute members of the electoral committee as well as the three members of the election appeal committee and two substitute members of the appeal committee.

4.

The members of the Committee are not permitted to serve for three consecutive terms.

5.

The FUFA Executive Committee meeting at which the Committee is appointed shall take place at least six months before the elective general assembly at which the executive body is elected.

6.

The FUFA General Assembly shall adopt the FUFA Electoral Code to guide on the operations of the Electoral Committee.

G. GENERAL SECRETARIAT

71 General Secretariat

The general secretariat shall carry out all the administrative work of FUFA under the direction of the Chief Executive Officer. The members of the general secretariat are bound by the internal organisational regulations of FUFA and shall fulfil the given tasks in good faith.

72 Chief Executive Officer

1.

The Chief Executive Officer is the chief executive of the general secretariat.

2.

He shall be appointed on the basis of an agreement governed by the Employment Act and shall have the necessary professional qualifications.

3.

He shall be responsible for:

- a) implementing decisions passed by the General Assembly and Executive Committee in compliance with the President's directives;
- b) Attending the General Assembly and meetings of the Executive Committee, Emergency Committee and the standing and ad-hoc committees;
- c) Organising the General Assembly and meetings of the Executive Committee and other bodies;
- d) Compiling the minutes for the meetings of the General Assembly, Executive Committee, Emergency Committee and standing and ad-hoc committees;
- e) Managing and keeping the accounts of FUFA properly;
- f) The correspondences of FUFA;
- g) Relations with the Members, committees, FIFA and CAF;
- h) Organising the general secretariat;
- i) The appointment and dismissal of staff working in the general secretariat;
- j) Proposing managerial staff to the President.

4.

The Chief Executive Officer shall not be a General Assembly delegate or a member of any body of FUFA.

5.

The President shall appoint the managerial staff (Directors) in the general secretariat on the proposal of the CEO.

73 Legal Entities Owned by FUFA

1.
Part of The Executive Committee of FUFA shall be the Board of Directors of the different Legal Entities owned by FUFA and created under these statutes.
2.
The FUFA President shall be the Chairperson of the Board of Directors of each of the legal entities owned by FUFA under these statutes. The boards may be composed of Seven (7) members where at least 4 members shall be members of the Executive Committee of FUFA.
3.
The FUFA Executive Committee shall appoint the members of boards of directors of the different Legal Entities owned by FUFA and created under these statutes.
4.
The exchange of services and value between FUFA and each of the Legal Entities owned by FUFA that are created under these statutes shall be governed as a business relationship established by contracts and/or agreements.
5.
The Auditors shall present their opinion of each of the Legal Entities owned by FUFA that are created under these statutes to the to the Members of FUFA at the General Assembly
6.
The Chairperson of the Board of Directors shall provide an annual report of each of the Legal Entities owned by FUFA that are created under these statutes to the Members of FUFA at the General Assembly
7.
The Documents of Registration and/or Incorporation of the Legal Entities owned by FUFA and created under these statutes shall include a clause recognising the supremacy of the FUFA statutes and shall be specific on the objectives of registration of and/or Incorporation of such Legal Entities
8.
In case the positions of the member of Executive Committee become vacant due to any reason, the respective person automatically ceases to hold his/her office of the board of Directors to the Legal Entities owned by FUFA and created under these statutes.

74 The Registered Trustees of FUFA

1.

The Registered Trustees of the Federation of Uganda Football Associations, incorporated under the Trustees Incorporation Act, Cap. 165 (the "Registered Trustees"), shall, upon the registration of FUFA as a body corporate under the National Sports Act, Cap. 151, cease to have any mandate or role in the administration, regulation, promotion or protection of the game of football in Uganda, and all such functions shall thereafter vest exclusively in FUFA, the body corporate. Notwithstanding the foregoing, the Registered Trustees shall continue in existence solely as the asset-holding entity in which FUFA's assets are vested and registered, and shall hold such assets for and on behalf of FUFA until such time as all FUFA assets are lawfully transferred and registered in the name of FUFA, the body corporate, in accordance with applicable law.

2.

The Statute of the Federation of Uganda Football Associations shall be the Statute/deed of the FUFA Trust. All decisions of the Trust shall be in accordance with this Statute.

3.

The persons occupying the position of the President, 1st Vice President and 2nd Vice President shall always be the Registered Trustees representing the FUFA Trust in all transactions.

4.

The term of office of the Registered Trustees of FUFA shall be congruent with term of office of the corresponding office of the President, 1st Vice President and 2nd Vice President. The president of FUFA shall be the president/ Chairperson of the Board of Trustees. Furthermore, all pertinent provisions including qualifications regarding office of the President, 1st Vice President and 2nd Vice President shall be applicable to the Registered Trustees of FUFA. In case the positions of the President, 1st Vice President and 2nd Vice President become vacant due to any reason, the respective person shall automatically cease to hold his/her office of the Registered Trustee.

5.

The Executive committee of FUFA shall be the same Executive board/board of governors of the FUFA Trust. All pertinent provisions including Qualifications regarding the Executive committee of FUFA shall be applicable to the executive committee/board of the Trust. In case the positions of the executive committee of FUFA become vacant due to any reason, the respective person on the trust executive shall automatically cease to hold office of the Trust Executive

V. FINANCE

75 Financial period

1.
The financial period of FUFA shall be one year and shall begin on 1 January and end on 31 December.
2.
The revenue and expenses of FUFA shall be managed so that they balance out over the financial period. FUFA's major duties in the future shall be guaranteed through the creation of reserves.
3.
The Chief Executive Officer is responsible for drawing up the annual consolidated accounts of FUFA with its subsidiaries as at 31st December.
4.
The annual audited books of accounts of FUFA shall be published in media of wide circulation.

76 Revenue

1.
The revenue of FUFA arises specifically from:
 - a) Members' annual subscriptions and any levies that may be imposed under these Statutes;
 - b) receipts generated by the marketing of rights to which FUFA is entitled;
 - c) fines imposed by the authorised bodies;
 - d) Leagues or Members contribution fee for development against sponsorship and commercial and media rights;
 - e) donations;
 - f) Borrowed funds
 - g) FIFA and CAF financial contributions;
 - h) Income generated by the Legal Entities created under these statutes;
 - i) Government of Uganda
 - j) other subscriptions and receipts in keeping with the objectives pursued by FUFA.

77 Expenses

1.
FUFA bears:
 - a) The expenses stipulated in the budget;
 - b) other expenses approved by the General Assembly and expenses that the Executive Committee is entitled to incur within the scope of its authority;
 - c) All other expenses in keeping with the objectives pursued by FUFA.

78 Independent and external auditors

1. Only the independent and external auditors appointed by the General Assembly shall audit the accounts approved by the Finance Committee in accordance with the appropriate principles of accounting and present a report to the General Assembly. The auditors shall be appointed for a period of two years. This mandate may be renewed.

79 Membership subscriptions

1. Membership subscriptions are due yearly on 30 June. The annual subscription for new Members for the year in question shall be paid within 30 days of the close of the General Assembly at which they are admitted.
2. The General Assembly shall fix the amount of the annual subscription every four years on the recommendation of the Executive Committee. It shall be the same for every Member and amount to Shillings 1,000,000 (one million).

80 Settlements

1. FUFA may debit any Member's assets to settle claims.

81 Levies

1. FUFA may demand that a levy be paid by its members for matches.

VI. COMPETITIONS AND RIGHTS IN COMPETITIONS AND EVENTS

82 Competitions

1. The FUFA Executive Committee shall annually, before the beginning of the season, generate a roster of the official Football Competitions. The roster shall include amongst others the following competitions.

2.

National Competitions (Men)

The National Competitions and these shall be composed of

1. The FUFA Uganda Cup
2. The FUFA Drum
3. The FUFA Inter-District Championship

National Men's League

3. The Professional League, these shall be composed of

1. The FUFA 1st Division League
2. The FUFA 2nd Division League

4. The Amateur League, these shall be composed of

1. The FUFA 3rd Division League (Regional Football Association Level)
2. The FUFA 4th Division League (FUFA Province level)
3. The FUFA 5th and 6th Division League (District Football Association Level)

Women Football Competitions

5. The Professional League shall be composed of

1. The FUFA Women Super League

6. The other women competitions shall be composed of

1. The FUFA Women Elite League
2. The FUFA Women Cup
3. The FUFA Women Regional League (Regional Football Association Level)

Youth Football Competitions

7. The Youth Competitions these shall be composed of

1. The FUFA Juniors League

8.

The Executive Committee may delegate to FUFA's subordinate Leagues the authority to organise competitions. The competitions organised by the Leagues shall not interfere with those competitions organised by FUFA. Competitions organised by FUFA shall take priority.

9.

In event of delegation of authority to organise competitions, FUFA shall automatically withhold the following responsibilities and may only delegate them in writing;

- a) Doping Management
- b) Referees Management (Appointment, Appraisal, Development and Disciplinary Matters)
- c) Authentic central registry of sanctions and fines of persons and entities
- d) Licensing of Clubs, Academies and Persons
- e) Registration, Status and Transfer of Player
- f) National Calendar of events
- g) Disciplinary matters of Predetermination of Sporting results
- h) Approval of Specific Competitions Rules

10.

The FUFA Executive Committee may create the 7th and 8th league competition and rank it above or below any of the 6-tier divisions leagues stipulated in article 82 (4).

11.

No league, group of clubs, club or member of FUFA shall organise any football competition without the written authority of FUFA.

12.

No player, official, referee, licensed agents or Member of FUFA shall participate in any football competition not authorised by FUFA.

13.

The Executive Committee may issue special regulations for this purpose.

83 Licensing

1.

The Executive Committee of FUFA will set up regulations regarding a club licensing system governing the participation of Clubs in competitions of FUFA.

2.

FUFA will proceed to granting of licenses to the clubs according to the club licensing system setting the minimum requirements adopted by CAF for granting of the license.

3.

The said club Licensing system includes in particular:

- a) The minimal criteria to be met by the clubs in order to be allowed to take part in the CAF competitions
- b) The procedure for granting the license to the clubs.
- c) The minimal requirements to be applied by the licensors.

VI. COMPETITIONS AND RIGHTS COMPETITIONS AND EVENTS

4.

The Executive Committee of FUFA will set up regulations regarding a licensing system governing the issuance of Licenses to other parties to undertake an activity that FUFA is mandated to undertake.

84 Rights

1.

FUFA and its Members are the original owners of all of the rights emanating from competitions and other events coming under their respective jurisdiction, without any restrictions as to content, time and place. These rights include, among others, every kind of financial rights audio-visual and radio recording, reproduction and broadcasting rights, multimedia rights, marketing and promotional rights and incorporeal rights such as emblems and rights arising under copyright law.

2.

The Executive Committee shall decide how and to what extent these rights are utilised and draw up special regulations to this end.

85 Authorisations

1.

FUFA and its Members are exclusively responsible for authorising the distribution of image and sound and other data carriers of football matches and events coming under their respective jurisdiction, and without any restrictions.

2.

The Executive Committee shall decide how the authorisation is done and may draw up special regulations to this end.

VIII. FINAL PROVISIONS

VII. INTERNATIONAL MATCHES AND COMPETITIONS

86 International matches and competitions

1.

The authority for organising international matches and competitions between representative teams and between Leagues, Club teams and/or scratch teams lies solely with FIFA, the Confederation(s) and/or the Association(s) concerned. No such match or competition shall take place without the prior permission of FIFA, the Confederation(s) and/or the Association(s) concerned in accordance with the FIFA Regulations Governing International Matches.

2.

FUFA is bound to comply with the international match calendar compiled by FIFA.

VIII. FINAL PROVISIONS

VIII. FINAL PROVISIONS

87 Contacts

1. FUFA, its Members, Players, Officials and match and players' agents shall not play matches or make sporting contact with Associations that are not members of FIFA or with provisional members of a Confederation without the approval of FIFA.
2. FUFA, its Members Associations, Clubs Players, Officials and match and player's' agents shall not play matches or make sporting contact with entities that are not members of FUFA unless authorised by FUFA in writing.

88 Approvals

1. Clubs, Leagues or any other group of Clubs that are affiliated to FUFA may only join another Association with the authorization of FUFA, the other Association, the respective Confederation(s) and FIFA.
2. Clubs, Leagues or any other group of Clubs that are affiliated to FUFA cannot participate in competitions on the territory of another Association without the authorization of the FUFA, the other Association(s), of FIFA and of the respective Confederation(s) according to the FIFA Regulations Governing International Matches.

89 Unforeseen contingencies and force majeure

The Executive Committee shall have the power to decide on all cases of force majeure and on all matters not provided for in these Statutes, such decisions to be made according to right and justice, taking into account the relevant regulations of FIFA and CAF.

90 Dissolution

1. Any decision relating to the dissolution of FUFA requires a majority of two-thirds [or any other majority as stipulated in the applicable national legislation] of all of the Members of FUFA, which must be obtained at a General Assembly specially convened for the purpose.
2. If FUFA is disbanded, its assets shall be transferred to either the National Council of Sports or the Uganda Olympic Committee. It shall hold these assets as a trustee in accordance with the relevant professional duties until FUFA is re-established. The final General Assembly may, however, choose another recipient for the assets on the basis of a two-thirds majority.

VIII. FINAL PROVISIONS

91 Enforcement

1.

Article 1(2) shall take effect and become operative only upon FUFA being duly registered by the National Council of Sports in accordance with the National Sports Act, Cap. 151.

2.

These Statutes were adopted at the FUFA Extraordinary General Assembly (virtual) held on 4th June 2026 and came into force on the same date, except as otherwise provided by any particular Article or by the General Assembly.
